CAPE FUNDING

- FLDOE has posted the draft list of the 18-19 CAPE Funding List (Industry Certifications that will bring a school bonus) at the following link: 18-19 CAPE Funding List
- This list provides any software version requirements, as well as the bonus point value (0.1 or 0.2).
 - Please note that the above list requires Microsoft Office Bundle 2013 version or later.
 - Please note that the above list requires all ADOBE exams be Creative Cloud, version 15 or later (CS 6 version exams are no longer effective this year).

DATA EXTRACTION

- During the 17-18 school year, Industry Certification data was extracted from BASIS to send to the FLDOE on Monday, July 23, 2018.
- Any data you may have entered in error in BASIS after that date will need to be
 provided to your school's IMS/IMT to be entered/changed in TERMS/External File. If
 your IMS/IMT has any questions on how to accomplish this task, they can contact the

GOLD STANDARD ARTICULATION AGREEMENTS

- The Gold Standard Articulation Agreements, which the FLDOE maintains with State
 Colleges, was updated, and several I.C.'s have been dropped (as state colleges no longer
 offer programs that match the I.C.'s). This means that some exams have dropped from a
 0.2 bonus FTE to a 0.1 bonus FTE. The exams effecting BCPS High Schools are:
 - O Child Development Associate (CDA) New FTE weight = 0.1
 - Quickbooks Certified User New FTE weight = 0.1
 - Microsoft Office Master New FTE weight = 0.1
 - Microsoft Office Specialist (MOS) New FTE weight = 0.1
 - Certified Internet Web (CIW) JavaScript Specialist New FTE weight = 0.1
- NOTE: The FLDOE has indicated that there is a plan to appeal this review, and they have
 a level of confidence that they will be able to change the above back to 0.2 by the end of
 the 18-19 school year. CTACE will keep you informed.

REGISTRATION OF 18/19 CAPE ACADEMIES

- The High School CAPE Academy Registration process is underway for the 18/19 school year. High School Principals are scheduled to receive a Pivot Memo with details and instructions by Monday, August 27th, 2018. The due date for submitting CAPE Academy nominations for the 18/19 school year is Wednesday, September 5th, 2018.
