SUBJECT: FLORIDA INVENTORY OF SCHOOL HOUSES CAPACITY UPDATE REPORT

This is to inform you that the Florida Inventory of School Houses (FISH) Capacity Update Report was revised and updated. Please note, that a few months ago the Facility Planning & Real Estate Department (FP&RE) staff discovered that the data generated by the Educational Facilities Information System (EFIS), contained errors which resulted in incorrect capacity for certain schools. Also, it was determined that this problem was occurring statewide. To address this problem, the FP&RE Department, at the direction of the Florida Department of Education (FDOE), has been manually correcting capacity data for the affected schools. The data used for this Report was updated based upon changes done during the period of April 13, 2022, to August 24, 2022. Therefore, the FDOE is currently working to remedy the problem and will notify Broward County Public Schools (BCPS) when the issue is resolved.

Attached please find the revised FISH Capacity Update Report. The permanent capacity for elementary schools decreased due to an adjustment in the capacity after the demolition of several buildings at Margate Elementary school; middle schools capacity increased due to adjustments after review and update of the FISH data. The permanent capacity for high schools and centers remains the same. Additionally, the portable capacity at middle and high schools decreased due to the demolition of the portables located at Falcon Cove Middle and Cypress Bay High school.

Also attached, is the current Portable Classroom Count Summary Report. The differences between the April 13, 2022, Capacity Update Report and this September 1, 2022, Capacity Update Report are shown in the following Tables. Table 1 is a summary of the permanent FISH capacity changes, and Table 2 is a summary of the Relocatable FISH capacity changes. Also attached is the CORE Dining Report.

Please be advised that the Facility Planning and Real Estate Department is working with the Demographics and Enrollment Planning Department, and the Information & Technology Department, to update the Planning Tool with related data from this Report.
