RE: 11th Grade FSA ELA Retake and In-School SAT

We will be administering the FSA ELA Retake (February 16 - March 11, 2021) and in-school SAT (March 3, 2021) to 11th grade students. The tests will be administered during the school day, on campus, face-to-face. CDC guidelines regarding personal protective equipment (PPE) and social distancing will be strictly followed.

FSA ELA Retake – February 16 – March 11, 2021

- This is a two (2) day test. Students will be scheduled on two (2) consecutive days anytime between February 16 – March 11, 2021.
- Achieving a passing score (level 3 or above) on the FSA ELA is a state graduation requirement.

In-school SAT – March 3, 2021

- This is a one (1) day test and will ONLY be administered on Wednesday, March 3, 2021.
- Students will be taking the SAT with no essay.
- There is no fee.
- A score of 480 or higher on the EBRW (Evidenced-Based Reading & Writing) may serve as a concordant for the FSA ELA state graduation requirement.

If your child is eLearning from home, you are responsible for providing your own transportation to and from school.
