



School Advisory Council (SAC) Meeting Minutes
October 26, 2021

1. Call to Order
 - a. A meeting of Millennium 6-12 Collegiate Academy Advisory Council was held via in the media center on 10/26/2021. Dr. Rodriguez called the meeting to order at 6:00 pm. Mrs. Yolanda Rivera recorded the minutes for this meeting.
 - b. Meeting opened with the Pledge of Allegiance.
2. Approval/Review of May 2021 SAC minutes.
 - a. Dr. Rodriguez read the minutes from September 2021. Ms. Janee Boyd put a motion to approve the minutes. Ms. Sandra Davila seconded the motion.
3. Principal's Report:
 - a. Face covering for High school students is optional, highly encouraged, but not optional for Middle School.
 - b. The Quarantine policy and the sanitizing protocols stays the same.
 - c. ESSER funds: We have 3 academic coaches: Science/8th grade: Ms. Y.Rivera, Reading/ELA/7th grade: Mr. Doyle, and for ELL/6th grade: Ms. Goodman.
 - d. ESSI funds: We are offering Before School tutoring (M-F 8:00-9:00am). In January, we will offer after school camps for FSA, AP, and EOC exams.
 - e. Title I funds: We will have planning period tutoring (pull outs during elective times).
 - f. Revised policies:
 - i. Homework: No homework can be assigned for breaks
 - ii. IEP Accommodations: Classroom accommodations needs to be the same as in the State Assessments.
 - iii. Students will need to take a Personal Finance course.
4. School Year 2022-2023 Block Scheduling:
 - a. Ms. Edun discussed a power point about the pros and cons of Block Schedule.
 - b. Unanimous votes were obtained to seek further information about scheduling and to present it to the faculty.
5. School Accountability Funds:
 - a. Accountability Balance: \$48,839.75
 - b. Pending purchase of desktops for Mr. Henderson's class: \$20,720.00. This was approved at the SAC Meeting on May 19, 2021. Once the order is processed, the balance will be \$28,119.75.
