Items or Clothing

- Garments with, slogans, emblems, motifs, stripes or patterns other than approved Parkway emblems and logos.
- Oversized pants, shorts or skirts
- Long oversized coats or jackets
- Shirts, tops unbuttoned below the chest
- Sweat pants, sweat shirts, jogging or athletic attire
- Tight fitting pants, tops, muscle shirts, tank tops, or tube tops
- Tattered clothes or garments with holes
- Frayed pants or shorts
- Cutoffs, mid-drifts, or unbuckled pants, shorts or skirts
- Hats or caps
- Suspenders
- Jeans or overalls (denim of any kind)
- Flip-flops, slippers, high heels, platforms, or stilettos. Open toed or backless shoes are not recommended for safety reasons.

Research has shown, the adoption of the Unified Dress Code policy, promotes safety, improves discipline, and enhances the learning environment.

We believe that when Parkway Middle school students are dressed and groomed in an appropriate manner their attire will not interfere with, or distract from, the school environment, nor will it disrupt the educational process.

The unified code clothing is typically less expensive than clothing students normally wear to school. Clothing should be suitable, comfortable and safe for normal school activities and reflect student pride.

**Unified Dress Code Guidelines~
All garments must be**

Selected from any of the following colors: navy blue, black, white, khaki, or gold, No emblems, logos other than unaltered approved Parkway Middle School Logos, or emblems may appear on any item of clothing.

• **Shirts**

Collared "Polo" style shirt (short or long sleeved). Any unaltered or approved **Parkway Middle T-Shirt** .

• **Pants**

"Dockers" style straight leg pants, plain dress belt. No denim, or overalls. Pants with belt loops must be worn with a belt. No tight fitting pants.

• **Shorts/Skorts**

"Dockers" style, fingertip length, walking short, cuffed or un-cuffed. No denim, or overalls. Shorts with belt loops must be worn with belts.

• **Skirts/Dresses**

Knee length pleated or un-pleated, solid school colors.

• **Shoes**

Sneakers, low-heeled shoes (2 inches or less) or boots with enclosed toes and backs. (suggested)

• **Sweat Pants and sweat shirts**

Sweat pants and sweat shirts in solid school colors will be permitted on days when the temperature falls below 60 degrees.
