

SAT Fee Waiver Eligibility

- You're enrolled in or eligible to participate in the National School Lunch Program (NSLP).
- Your annual family income falls within the <u>Income Eligibility Guidelines</u> set by the USDA Food and Nutrition Service.
- You're enrolled in a federal, state, or local program that aids students from low-income families (e.g., Federal TRIO programs such as Upward Bound).
- Your family receives public assistance.
- You live in federally subsidized public housing or a foster home, or are homeless.
- You are a ward of the state or an orphan.

ACT Fee Waiver Eligibility

- Enrolled in a federal free or reduced-price lunch program at school, based on USDA
- Enrolled in a program for the economically disadvantaged
- Resides in a foster home, is a ward of the state, or is homeless.
- Family receives low-income public assistance or lives in federally subsidized public housing.
- Family's total annual income is at or below USDA levels for free or reducedprice lunches on the USDA Food and Nutrition Service website.

College Visits

- All college visits will take place in the auditorium unless otherwise stated.

College Application Review

- Most colleges have a holistic review process, meaning they aren't just analyzing your academic achievements. They consider all aspects of our applicants.
 - SAT/ACT Scores
 - GPA/Transcript
 - Class Rank
 - Extracurriculars
 - Personal Essays
 - Letters of Recommendation
 - Not all colleges require a letter of recommendation.
 - If a school does not require a letter of recommendation, a letter will not be written.

How do I Apply?

Institutional Application: You apply directly on the institution's website.

Common Application: Explore and apply to more than 900 colleges and universities.

- The Common Application permits electronic submission from your school counselor and teacher recommendation.
- Universities that accept more than one application type have no preference on which one you choose, but make sure you only APPLY ONCE.
- You can apply to any number of the 65 HBCU's on the Common Black College Application for \$20. <u>https://commonblackcollegeapp.com/</u>

The Family Educational Rights and Privacy Act (FERPA)

- 1. How does FERPA relate to your college application?
 - FERPA regulates the privacy of student education records, which could include your application to the college where you enroll. FERPA also gives you the right to review confidential letters of recommendation provided as part of that application after you enroll.
- 2. In the application you'll be asked if you want to waive the right to review confidential letters of recommendation. What you should you know about this waiver?
 - Waiving your right lets colleges know that you do not intend to read your recommendations, which helps reassure colleges that the letters are candid and truthful.
 - Some recommenders may decline to write a letter for you if you do not waive your rights. Check with your counselor or teachers to see if any of them follow such a policy.

Self-reported Student Academic Record (SSAR)

What is the Self-reported Student Academic Record (SSAR)?

- SSAR is a self-reported student academic record that lists all courses and associated grades that have been attempted, or will be attempted, for high school and/or college credit. Since accuracy is critical, you must have a copy of your high school transcript available to use as a reference when you create your SSAR. Be sure to indicate any courses taken through an online school. *Broward Virtual Counselor
- Do I need to include high school courses taken while I was in middle school/junior high school?
- Yes. Every academic course that you have attempted for high school credit while in middle school/junior high school must be listed on the SSAR.
- How do I submit my SSAR to the university?
- Once you submit your application, you will receive follow instructions on to how link your SSAR to your application.

Self-reported Student Academic Record (SSAR)

- How do I enter my grades on the SSAR?
- The SSAR collects grades on a semester basis. Please refer to the following examples to guide your grade submission. If your high school transcript has:
- Only semester grades: Enter your semester grades as shown on your transcript.
- Only final grades: Enter the final grade twice (first semester and second semester) for yearlong courses (one credit), and once for semester-long courses (1/2 credit). For example, if you earned a grade of B in Algebra I which is a yearlong course (1 credit), enter that grade twice (first semester and second semester).
- Both semester grades and final grades: use the final grade. For example, if you took Algebra I earning an A in the first semester and a B in the second semester with your final grade being a B, enter a grade of B twice (first semester and second semester).
- How do I enter my Dual Enrollment Courses?
- If your dual-enrollment course is one credit in high school, enter the grade twice (first semester and second semester). If your dual-enrollment course is 1/2 credit, enter the grade once (either first semester or second semester).

Self Provided Academic Record for Knights (SPARK)

• What is the Self Provided Academic Record for Knights (SPARK)?

• The SPARK form is an online portal through which first-time-in-college applicants self-report their high school courses and grades for admission to the University of Central Florida.

Where do I submit and create my SPARK form?

 Once your application is received and processed, a link to the SPARK form will be available on your myUCF account.

How do I update my SPARK form if my schedule changes?

 Once your SPARK form is submitted, it will be locked and no further updates will be possible. You will have the opportunity to indicate schedule changes and add first semester grades once they are available (typically after the New Year).

How do I enter grades on the SPARK form?

- You are required to have a copy of your current high school or homeschool transcript available to refer to when completing the SPARK form. * Broward Virtual Counselor

College Application Fee Waiver Request
What's the difference between a college application fee

- waiver and an SAT fee waiver?
 - An SAT fee waiver allows you to register for the SAT or an SAT Subject Test free of charge. A college application fee waiver allows you to apply to college without paying an application fee.
- Do all colleges accept application fee waivers?
 - No, not all colleges accept application fee waivers

Scenario #1: You're Using the Common Application

- In your Profile section, you'll indicate whether or not you qualify for a fee waiver, and then you'll select your reason why. The screen will look like this:
- If you select yes, you'll be prompted to select an indicator of economic need:
- If you already got an SAT or ACT fee waiver, then your counselor should be able to sign off on this automatically. If not, you will have to inform your counselor how you qualify.

Scenario 2: You Took the SAT or SAT Subject Tests With a Fee Waiver

- If you took the SAT or one or more SAT Subject Tests with a fee waiver, you'll automatically get unlimited college fee waivers from the College Board (as long as the colleges allow fee waivers to be used).
- You can also search for schools that accept application fee waivers to see whether your schools of interest allow you to use a waiver.

Scenario 3: You Need Alternative Fee Waiver Forms

- Fortunately, there are a few other forms you can use if you're applying to a school not on the Common App you didn't use an SAT fee waiver.
- There are two main forms your counselor may distribute: the ACT waiver or the NACAC waiver.
- The ACT Waiver
 - Unlike the College Board, ACT doesn't automatically grant its test fee-waiving students with application fee waivers.

- The NACAC Fee Waiver

- 5. Ask for letters of recommendations if applicable.
- 6. Ask for individuals to proofread your essays.

January 1st for some colleges/universities

- Apply for scholarships. Naviance has a list of scholarships!
- Meet deadlines! Ideally, you should have all applications complete by November 1st if you are ready.
- Requests for Letters of Recommendation no later than October 15th, 2021
- Email a copy of your acceptance letters and copies of any scholarships received to Ms. Colon.
- Once accepted, research the school's financial aid office
