All BCPS Summer VPK instructors hold a Florida Teachers Certificate in Early Childhood Education. The free, BCPS Summer VPK program is available to children that turned 4 years old by 9/1/21, will be entering Kindergarten in the Fall, and <u>did not use</u> their VPK Certificate of Eligibility during the 2021-2022 school year.

2022 Summer Voluntary Prekindergarten (VPK) Directions to Apply

To participate in any VPK program, parents/guardians must apply for, receive and submit a 2021-2022 VPK Certificate of Eligibility or 2021-2022 VPK Re-Enrollment Certificate of Eligibility. Follow the steps listed below.

- Step 1: Obtain your child's 2021-2022 VPK Certificate of Eligibility or 2021-2022 VPK Re-Enrollment Certificate of Eligibility through the State's Family Portal. https://familyservices.floridaearlylearning.com/Account/LogOn
- Step 2: Bring the following to one of the schools listed below:
 - NOTE: Applications and forms for Margate Elementary must be brought to Wingate Oaks Center
 - Signed & Dated VPK Certificate of Eligibility
 - Completed Summer VPK Pre-Registration Form
 - Child's Birth Certificate
 - Proof of Broward County Residence
