CCHS CLASS OF 2019 PROM REGULATIONS

In an effort to assist you in purchasing proper Prom attire in a timely manner and to prevent you from purchasing clothing that will <u>not</u> be permitted, be advised that the dress code for Prom is <u>Formal Attire</u> that meets the following restrictions:

<u>Acceptable for Females:</u> one-piece dresses that show no part of the midsection (front or sides) or any private parts. All skirt slits **must end no higher than mid-thigh**.

<u>Acceptable for Males:</u> a tuxedo/suit. Young men may NOT remove any clothing other than their jackets in the event they become overheated.
