DISCUSS SCHOOL BOARD MEMBER REDISTRICTING**

With the release of the 2020 US Census, Broward County Public Schools is undertaking the work of redrawing School Board Member voting districts. This process occurs every ten years in order to ensure that all districts are balanced in terms of total population, taking into account population changes that occurred since the previous census.

It is very important to note that the redistricting process **does not affect** school boundaries or student school assignment, but merely the voting areas for single-member school board districts.

Members of the public will have several opportunities to participate in the redistricting process and have their voices heard. These opportunities are listed on the attached flyer. Please share the flyer with your school community, including SAC, SAF, PTA and through your school's ParentLink.

## Invitation to Participate in Community Meetings on Broward County Public Schools Redistricting Process

Dear Resident:

In 2021, Broward County Public Schools, like all other school districts in Florida, must redraw its single-member school districts to account for changes in population since the last decennial census. Redistricting is the process of drawing boundaries for political districts to account for population shifts. Redistricting of School Board Member Voting Districts DOES NOT impact student attendance boundaries or transportation.

Broward County Public Schools selected Florida International University (FIU) as its consultant for the redistricting process. FIU is conducting an open and transparent process utilizing current, generally accepted methods and standards for the development of redistricting plans. Public input is key to the effort.

You are invited to attend any one of four community meetings to obtain information about the process and to provide input. If you are unable to attend one of the on-site meetings in person, we invite you to participate in the virtual meeting.
