<p>Violation #55. Facilities installed, maintained, & clean Ceiling tiles stained over oven area near food prep sink. Replace/replace ceiling tiles. CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.</p>
<p>Violation #56. Ventilation & lighting Observed lightbulb not working in SOMAT/PULPER room. Repair/replace lightbulb (Repeat Violation) CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.</p>
