- b. Council members representing teachers, education support employees, students, and parents shall be elected by their representing peer group at the school in a fair and equitable manner as follows:
 - i. Teachers shall be elected by teachers.
 - ii. Education support employees shall be elected by education support employees.
 - iii. Students shall be elected by students.
 - iv. Parents shall be elected by parents.
