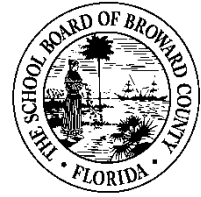

## 2013-14 Annual Customer Survey of Students, Teachers, Parents and Non-Instructional Staff

The 2013-14 school year marks the 20<sup>th</sup> anniversary of the Annual Customer Survey. The purpose of the survey is to measure perceptions of school climate held by Students, Parents, Teachers, and, for the first time this year, school-based Non-Instructional Staff. Survey results are intended to be used for a variety of purposes including supporting **communication** between schools and their communities, school improvement **planning**, and instructional climate **measurement**.

The survey forms and procedures were substantially altered for the present administration based on feedback from teachers, principals, and District staff. The resulting surveys were designed to measure perceptions related to the three goals of Broward County Public Schools' (BCPS) Three-year Strategic Plan (*High Quality Instruction, Continuous Improvement, and Effective Communication*). In addition, survey questions measured four key components of school climate; *Collaborative Teaching, Instructional Practices, School Leadership, and Supportive Environment*.<sup>1</sup> In addition, survey participants were provided an opportunity to list up to five issues they would like to raise with their school principal and District administration. Table 1 displays the climate areas surveyed for each of the respondent groups.

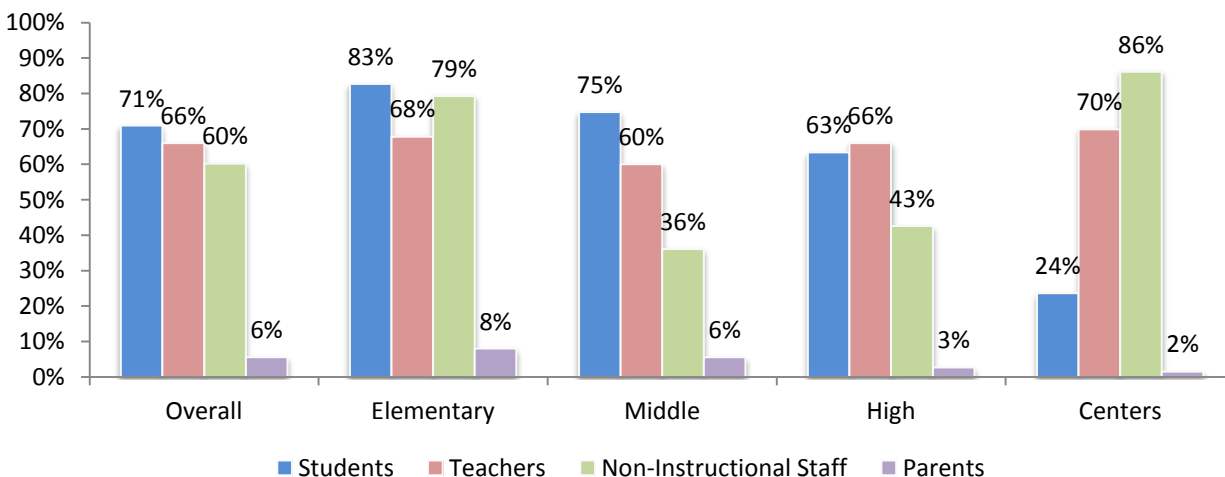

In a change from prior years, participants were not required to log into Virtual Counselor to access the survey. Instead, access to the survey was available through the main District website ([www.browardschools.com](http://www.browardschools.com)). Participants selected the appropriate survey corresponding to their role in the District (*Student, Parent, Teacher, or Non-Instructional Staff*). Data collection and storage was anonymous.<sup>2</sup> Surveys were available for five weeks from February 17 to March 21, 2014.

## Participation

Figure 1 displays the participation rates by respondent group and school level. A total of 120,347 students, 9,800 teachers, 3,578 non-instructional staff, and 10,743 parents submitted valid surveys, yielding estimated response rates of 71%, 66%, 60%, and 6%, respectively.<sup>3</sup> Participation tended to be highest at the elementary level and decreased through the middle and high school levels. Non-instructional staff, who participated for the first time this year, registered an overall participation rate of 60%, with strong participation at the elementary schools and centers. Parent participation was low with an overall rate of 6%.

The student, teacher, and parent participation rates were lower than in prior years, due in part to changes in the administration procedures (overall 2012-13 participation rates were 81%, 73%, and 12% for students, teachers, and parents, respectively). Participants were not required to log into the District's Virtual Counselor to access the survey, thereby eliminating the ability to identify who had or had not completed the survey and precluding targeted reminders to individuals. In addition, paper survey administration was not supported by the District this year, which may have contributed to a decrease in participation among parents.

<sup>3</sup> Numbers represent valid surveys. The inclusion criteria included: minimum of 10 survey questions answered (5 for non-instructional staff), identification of a valid school location, and having been at the school for more than one month (student and parent surveys). Respondents indicating attendance or employment at a charter school are not included in these analyses.

## Composite Scales

Survey items were grouped to form scales for the purpose of summarizing broad perspectives of the participants. Three scales were related to the three components of the Broward County Public Schools' Strategic Plan: *High Quality Instruction*, *Continuous Improvement*, and *Effective Communication*. Four additional scales tapped key areas of the school climate: *Collaborative Teaching*, *Instructional Practice*, *School Leadership*, and *Supportive Environment*. Questions were presented as five-point Likert-type items with options ranging from (1) *Strongly Disagree* to (5) *Strongly Agree* with a *Don't Know* option as a sixth choice. The number of items comprising each scale ranged from 3 to 16. Cronbach's Alpha coefficients were computed to assess the reliability of each scale, or the degree to which items are inter-related and thereby provide a meaningful measure of a general topic. The coefficients can range from 0 to 1, with values closer to 1 indicating a higher degree of agreement among items within the scale. Items comprising a common scale should have a strong Alpha coefficient ( $\alpha$ ). Table 2 displays the number of items comprising each scale and  $\alpha$ . The Alpha coefficients tended to be in the moderate to high range.

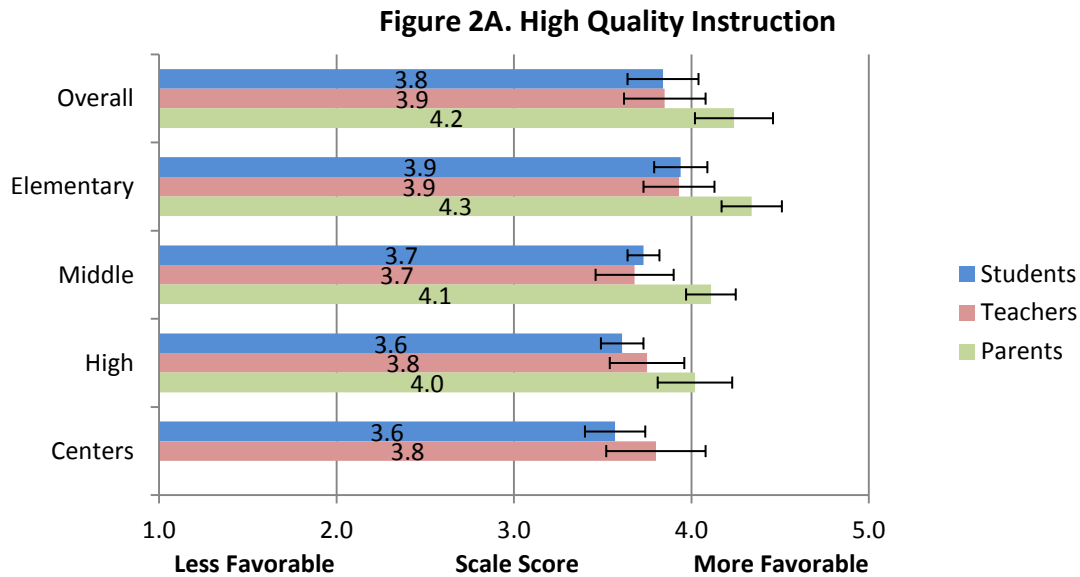

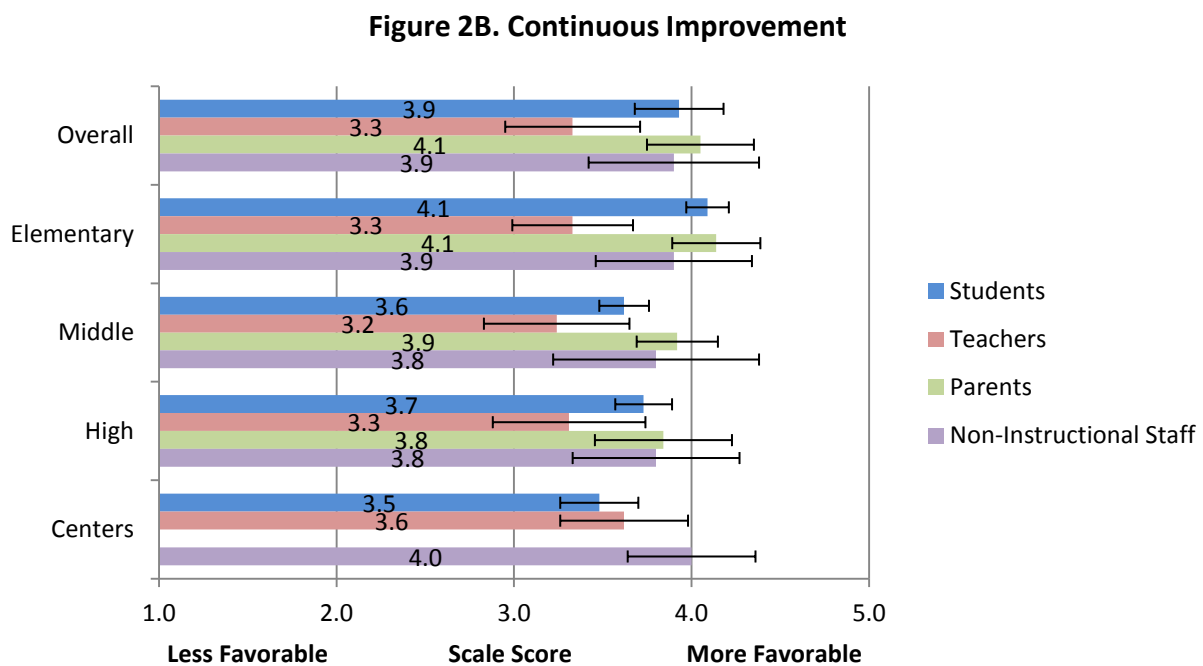

Survey items comprising each scale were averaged to obtain the composite score for each participant. These participant-level scale scores were then averaged to create scores at the school level. The scores could range from 1 to 5, with higher scores representing more favorable perceptions. Figures 2A, 2B, and 2C illustrate the average school-level perceptions for the three Strategic Plan scales by level and respondent group. Error bars denote one standard deviation in school-level averages and are provided as a reference of variability in school-level ratings across the District. Data are not reported for parents of students attending centers due to low participation.

Inspection of Figure 2A revealed that all participant groups expressed positive views with regard to *High Quality Instruction*. Students and teachers expressed similar views as denoted by the blue and red bars being of similar length and the overlapping error bars. By contrast, the responding parents tended to give more positive ratings. Values for non-instructional staff are not reported for this scale.

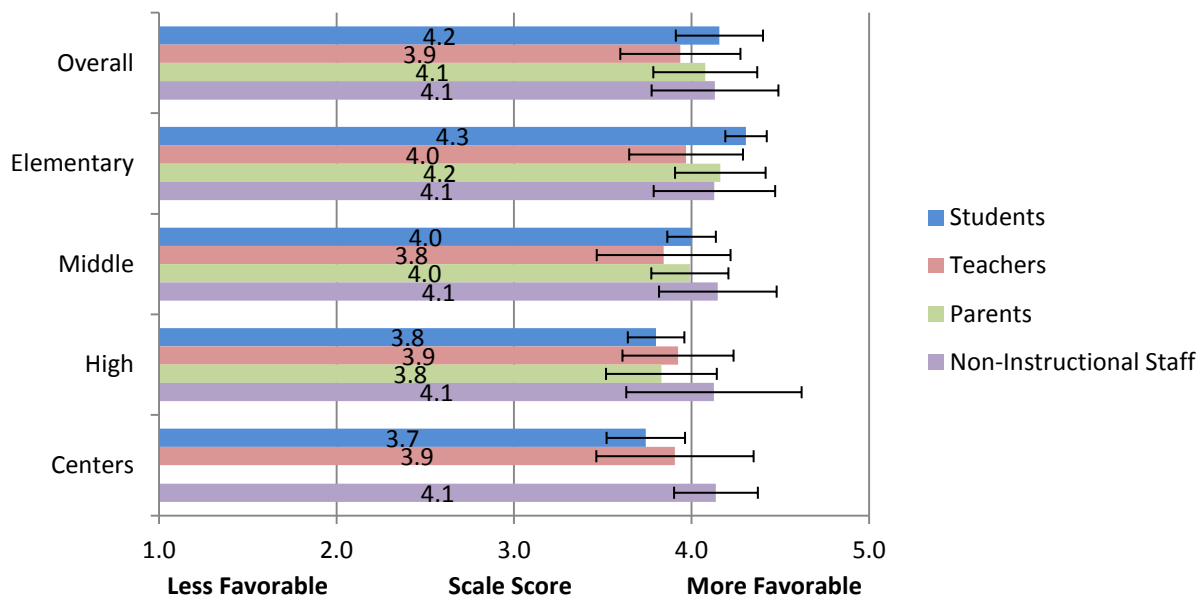


Overall, students and parents tended to give higher ratings with regard to *Continuous Improvement*, particularly at the elementary, middle, and high school levels (Figure 2B). Non-instructional staff tended to give higher ratings of *Continuous Improvement* than did their teacher-colleagues. These patterns were consistent across school levels with the exception of centers.



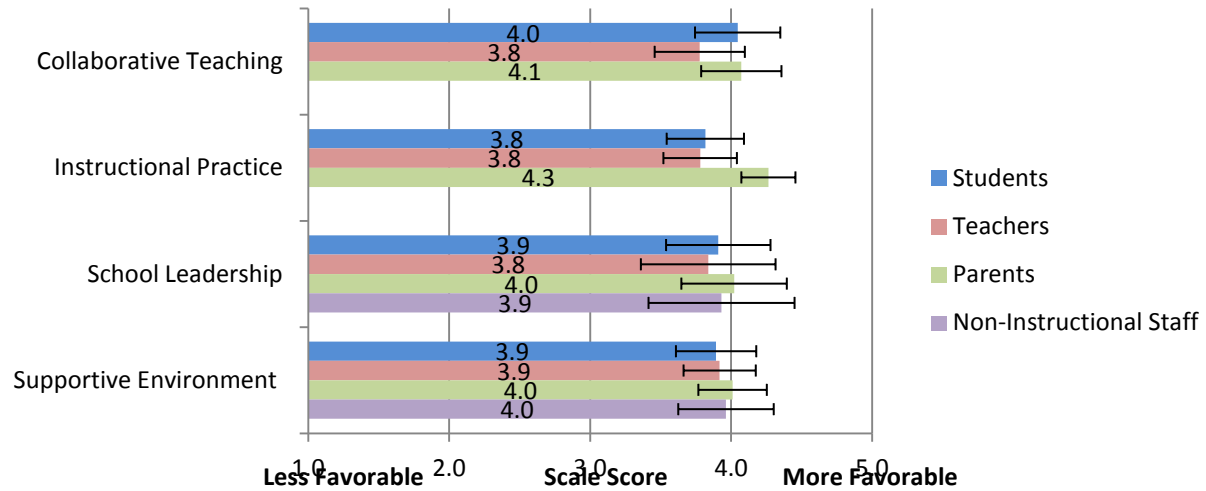
Overall, the four participant groups rated their school positively with regard to *Effective Communication*. At the elementary and middle school levels, teachers tended to give lower ratings compared to the other groups. High school students tended to give lower ratings than the younger student participants, suggesting an opportunity for improved communication with high school students.

In addition to the three Strategic Plan related scales, four scales summarized responses to questions addressing aspects of the school climate: *Collaborative Teaching*, *Instructional Practice*, and *Supportive Environment*. Figure 3 displays the average school-level ratings. Overall, all respondent groups registered positive ratings of the school climate. Each of the groups reported similar ratings on average, although the participating parents tended to give more positive ratings of *Instructional Practice* than either students or teachers. Non-instructional staff were included in ratings of the *School Leadership* and *Supportive Environment* and provided similar favorable ratings as each of the other participant groups. Table 5 provides the disaggregated scores by respondent group and school level. On average, ratings tended to be positive and similar across school levels. Elementary students tended to provide higher ratings on each of the climate scales than did students at other levels.

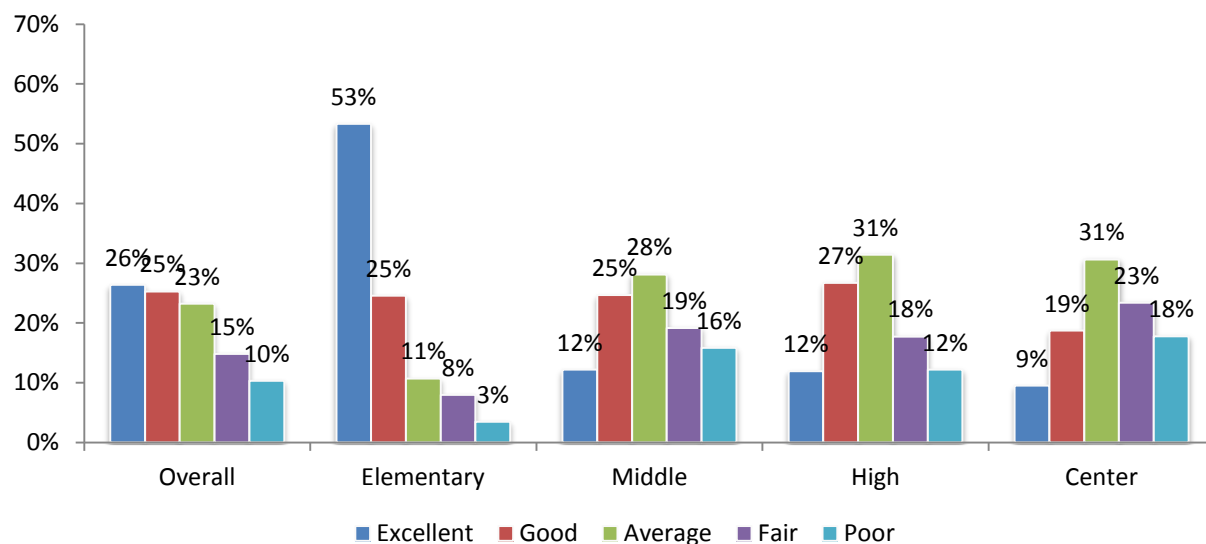

## Highlights of Selected Items

The scales summarized in the previous sections provide a high-level index of the perceptions reported by *Students, Teachers, Parents, and Non-instructional Staff*. These indices are useful for gaining a broad understanding of the perceptions of the climate in BCPS schools. They do not, however, cast light on specific issues. Responses to individual questions must be examined to gain a deeper understanding of stakeholders' perceptions. Responses for all items are summarized in the Appendix; summaries are provided overall and by school level for each respondent group. This section highlights responses to selected items.

As an overall assessment, all respondents were asked to rate the school's environment on a five-point scale from *Poor* to *Excellent*. Figures 4A, 4B, 4C, and 4D display the responses for students, teachers, parents, and non-instructional staff, respectively. Nearly three-quarters of students and parents at the elementary level rated their school's environment as "excellent" or "good." These ratings by the elementary representatives are more favorable than the ratings provided by representatives at other school levels, with an exception for teachers and parents of students attending centers. Middle and high school students tended to provide similar ratings of their schools, with "average" being the most frequent score. Also of note, the responding teachers and parents rated the environment at the centers highly, with 40% of teachers and 61% of parents providing ratings of "excellent."<sup>4</sup>

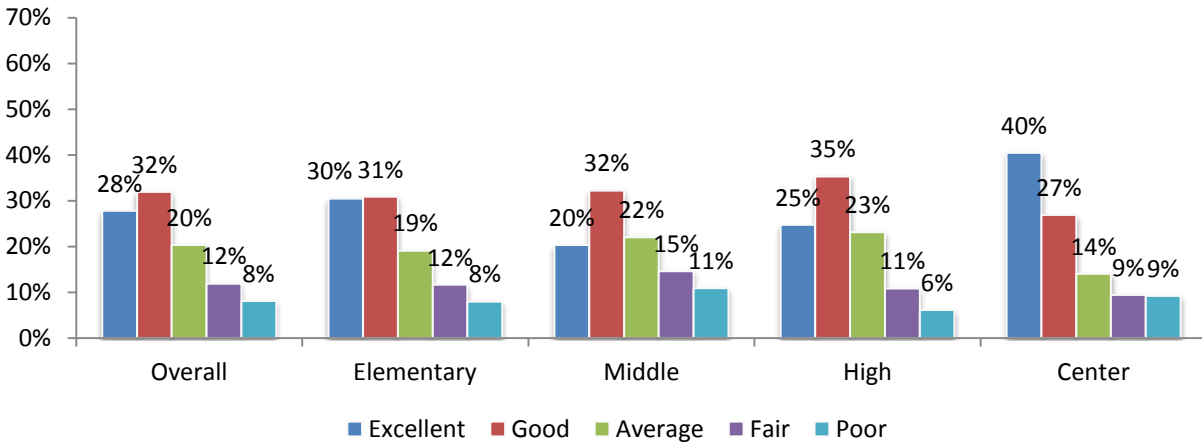
**Figure 4A. Students: How do you rate your school's environment overall?**



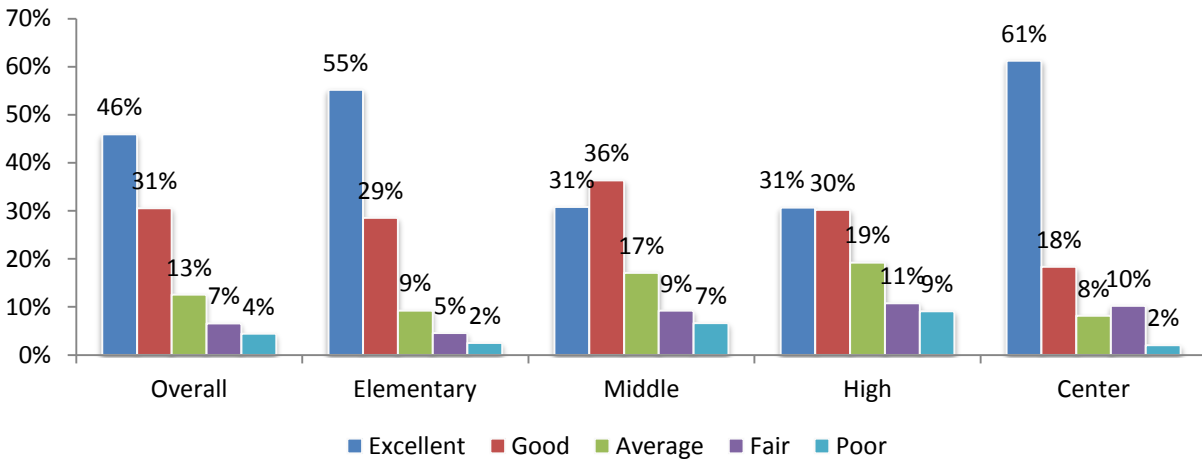

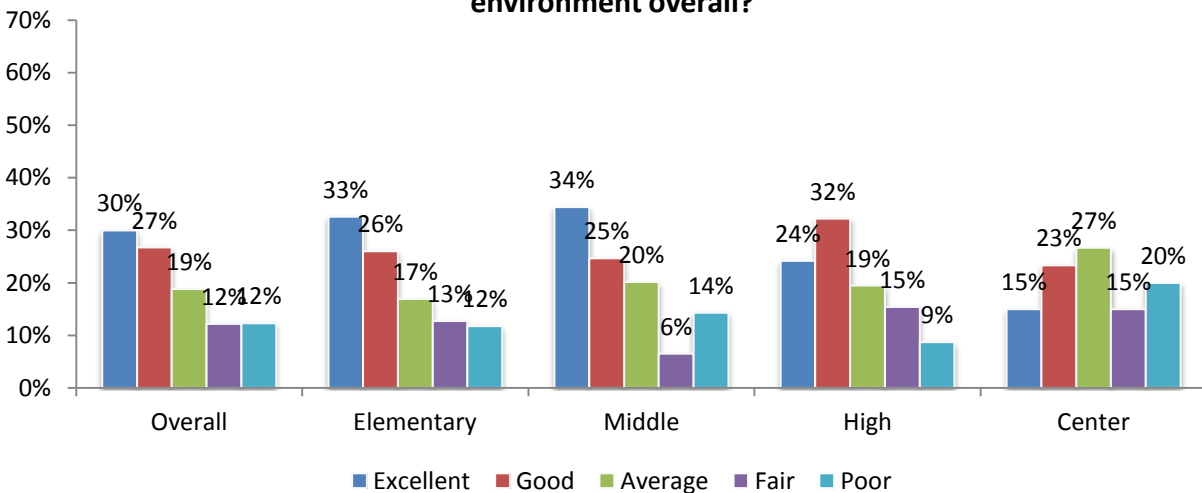
**Figure 4B. Teachers: How do you rate your school's environment overall?**



**Figure 4C. Parents: How do you rate your school's environment overall?**

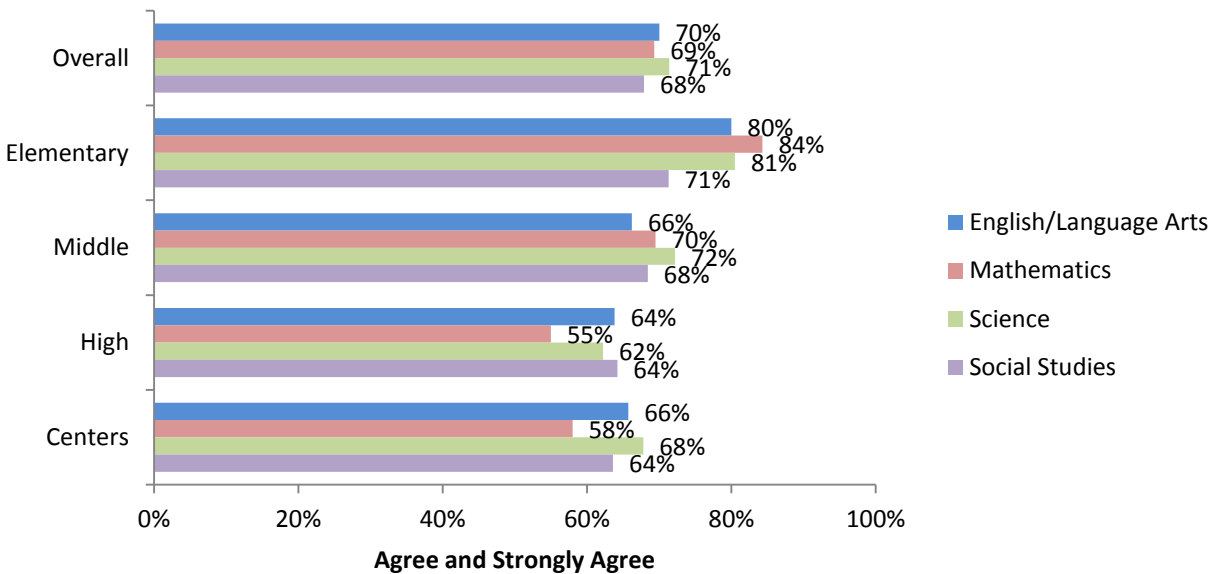


**Figure 4D. Non-Instructional Staff: How do you rate your school's environment overall?**



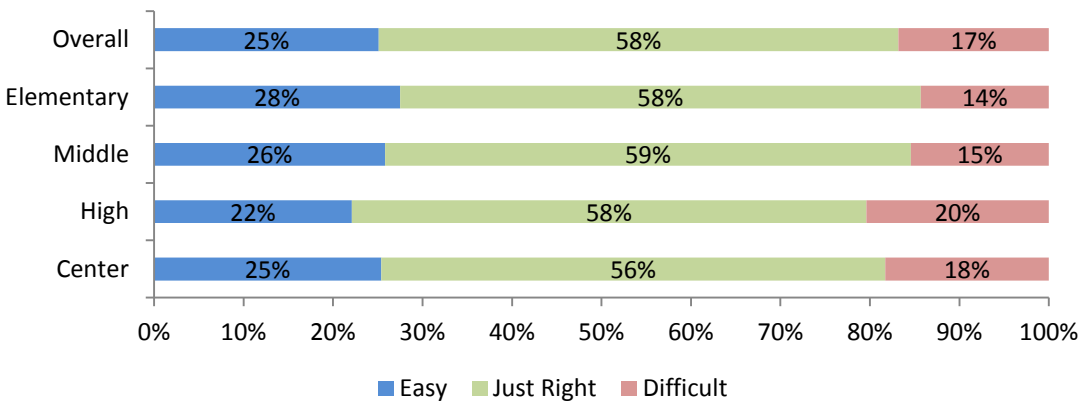
Student engagement in learning is essential to academic success. Students rated their interest in what is being taught in the four core subject areas (Figure 5). A consistent pattern was found for each subject: elementary students registered the highest level of interest, with interests waning at the middle and high school levels. The most dramatic difference occurred with mathematics, decreasing from 84% of elementary students professing interest to 55% of high school students.

**Figure 5. Students reporting interest in what is taught**



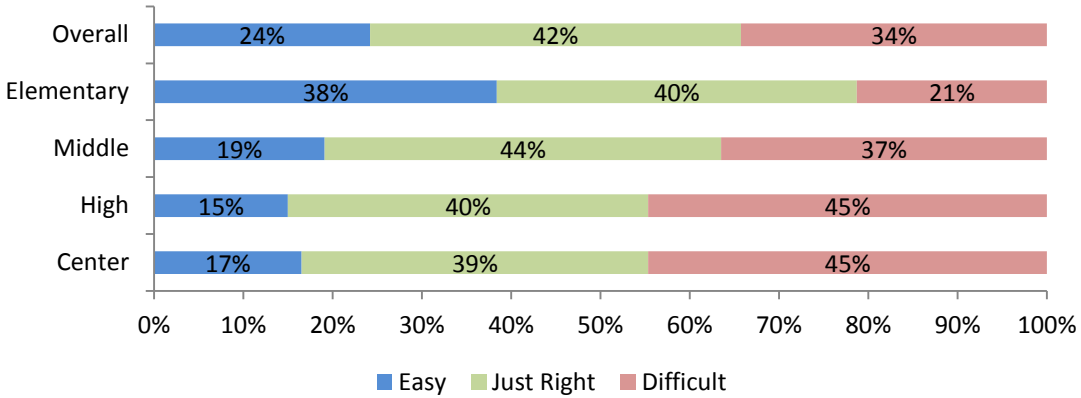
In addition to interest, lessons and assignments need to be appropriately challenging. Too easy and students lose interest, too difficult and students get frustrated. Students rated the level of difficulty of the classes they are taking in each of the four core areas (Figures 6A, 6B, 6C, and 6D). Ratings were made on a five-point scale from *Too Easy* to *Too Difficult* with *Just Right* denoting the midpoint.<sup>5</sup>

**Figure 6A. Students: Difficulty of English/Language Arts Classes**

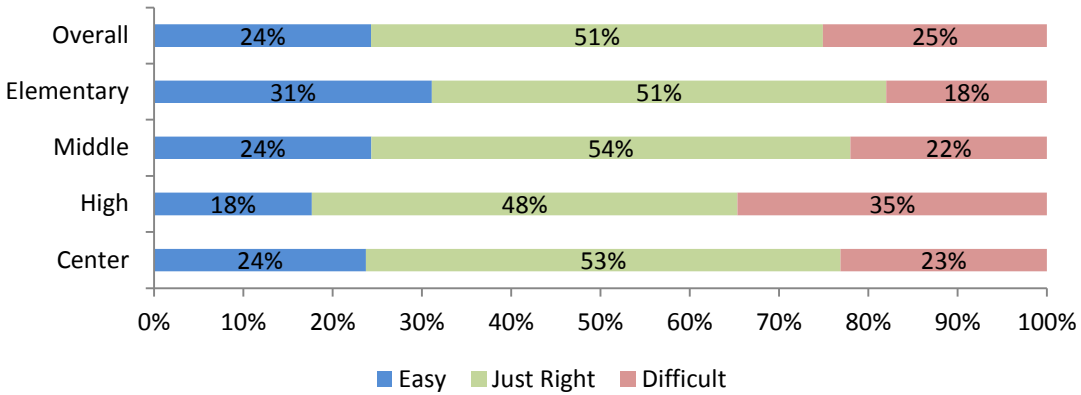

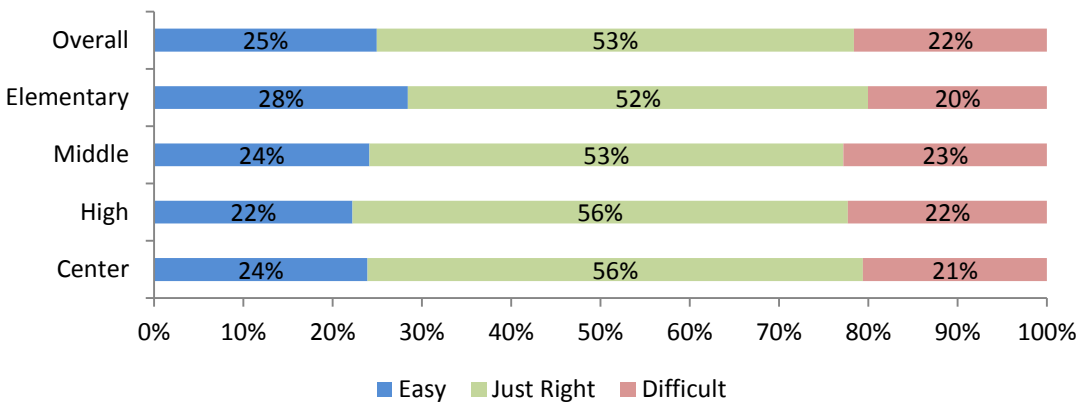
**Figure 6B. Students: Difficulty of Math Classes**

**Figure 6D. Students: Difficulty of Social Studies Classes**

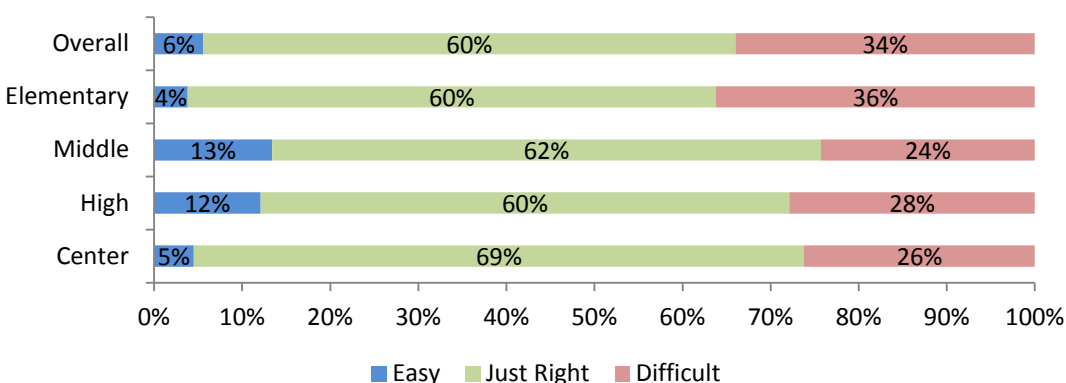


Review of Figures 6A to 6D indicate that students view math and science classes as more difficult than English/Language Arts or Social Studies classes. The percent of students rating math and science as difficult increased with school level. While 21% of elementary students

rated math as difficult (38% said it was easy), 45% of high school students rated math as difficult. These data suggest that the relative level of rigor is not consistent across school levels.

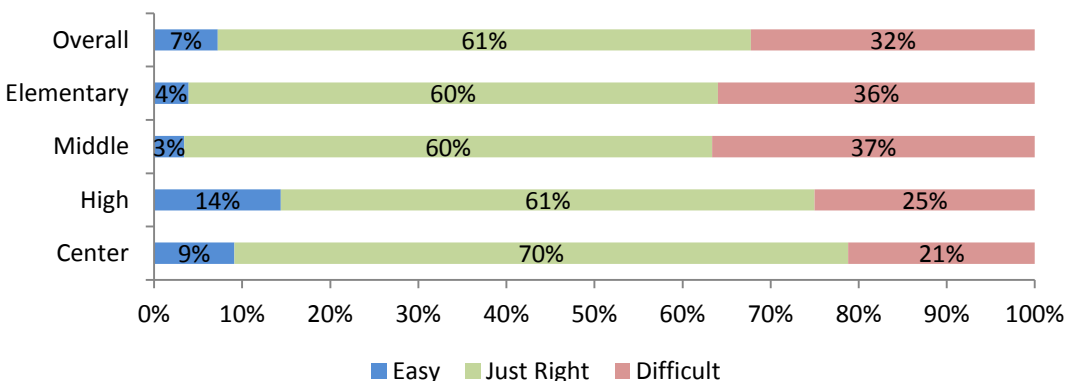
Teachers provided their perspectives of the learning expectations for their subject areas (Figures 7A, 7B, 7C, and 7D). The English/Language Arts teachers (Figure 7A) believed that the instructional expectations are more difficult than ratings provided by the students would suggest (Figure 6A). That is, 25% of students overall indicated that English/Language Arts classes were easy (17% difficult) while only 6% of teachers said the learning expectations were easy (34% said they were difficult).

**Figure 7A. Teachers: Learning Expectations in English/Language Arts**



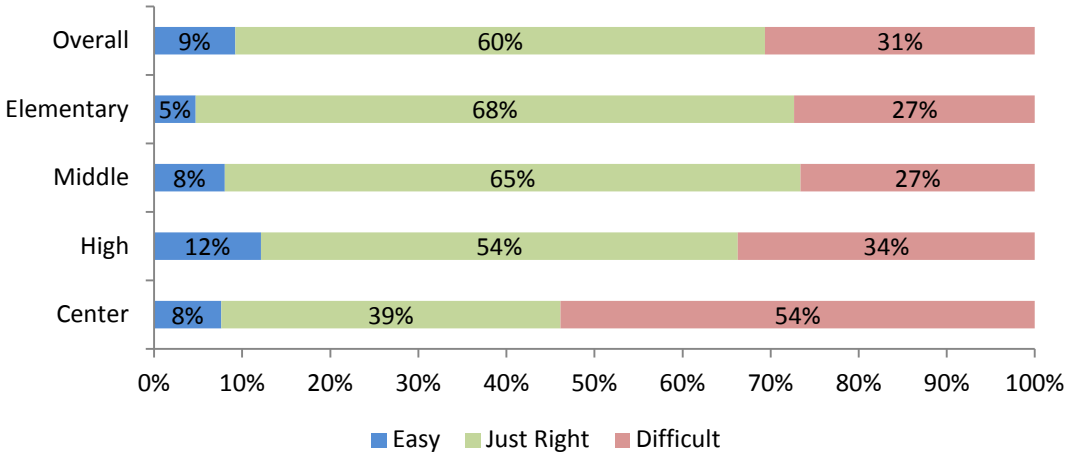
Teachers' assessment of expectations in math (Figure 7B) also diverged from student's reported experience (Figure 6B). A substantial proportion of elementary students found math to be easy (38%) while only 4% of their teacher rated the elementary expectations as easy. Nearly one-half (45%) of high school students rated math classes as difficult, but only 25% of their teachers rated the expectations as difficult.

**Figure 7B. Teachers: Learning Expectations in Math**

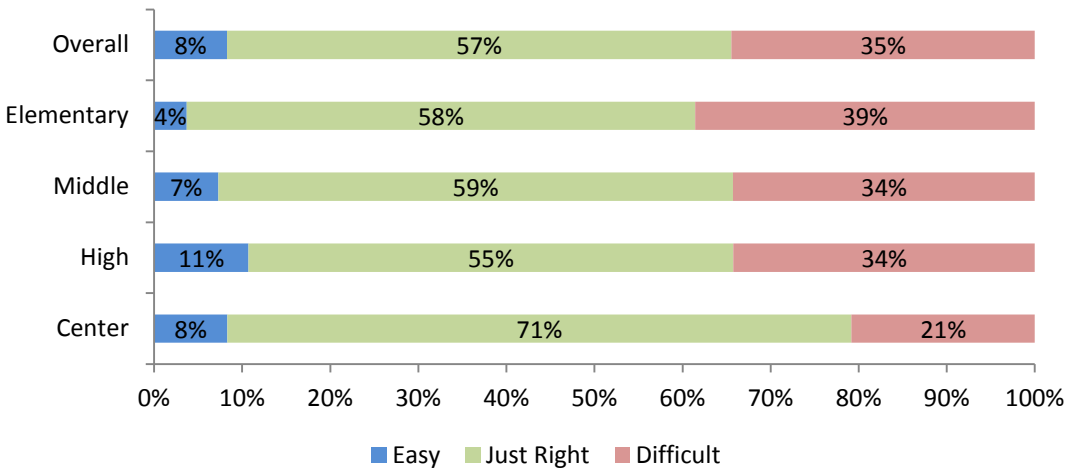


Many students also reported that the science and social studies classes were easier than would be expected given the teachers' ratings of the expectations (Figures 7C and 7D).

**Figure 7C. Teachers: Learning Expectations in Science**



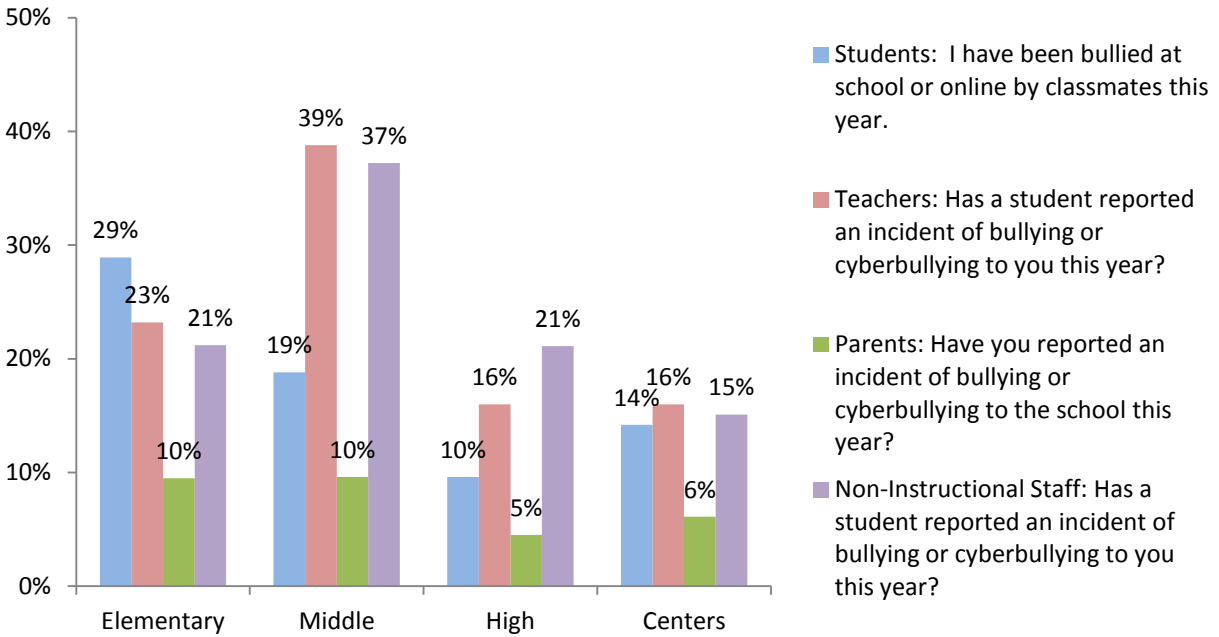
**Figure 7D. Teachers: Learning Expectations in Social Studies**



Students' feelings of safety at school are also critical to learning. Bullying is one aspect of safety that has received much recent attention in the media; a recent Google search for news reports about bullying in schools revealed 23,700 reports in the United States from January 1 to April 21, 2014. The present survey included bullying-related questions, including asking students if they have been bullied this year and asking adults if students have reported bullying this year. As shown in Figure 8, students in elementary school were most likely to say that they have been bullied this year (29%), with high school students least likely (10%). However, middle school teachers (39%) and non-instructional staff (37%) were most likely to say that a student has reported an incident of bullying to them.<sup>6</sup>

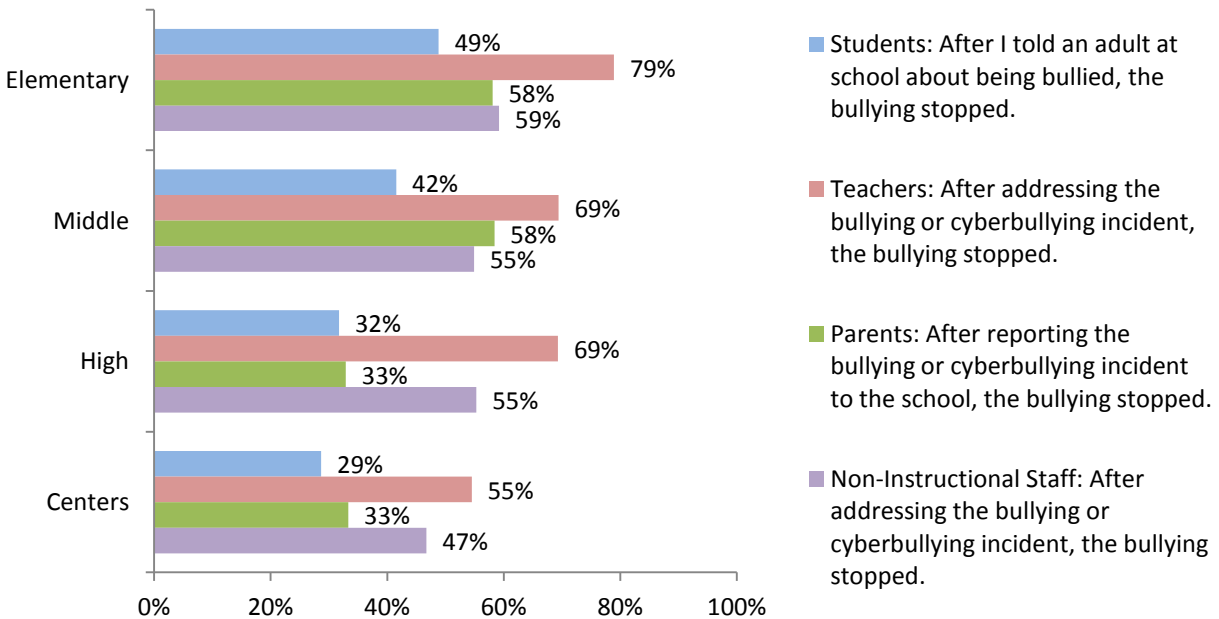

A separate item assessed perceptions concerning the impact of adult intervention in bullying at school (Figure 9). Students who said they had been bullied or teachers who said they had intervened in bullying indicated whether the bullying stopped, remained the same, or got worst after the adult’s involvement. Inspection of the figure suggests that teachers felt that their intervention was more effective in stopping bullying compared to reports from students. This difference in perception was apparent across all school levels.

**Figure 9. Adult's Impact on Bullying**

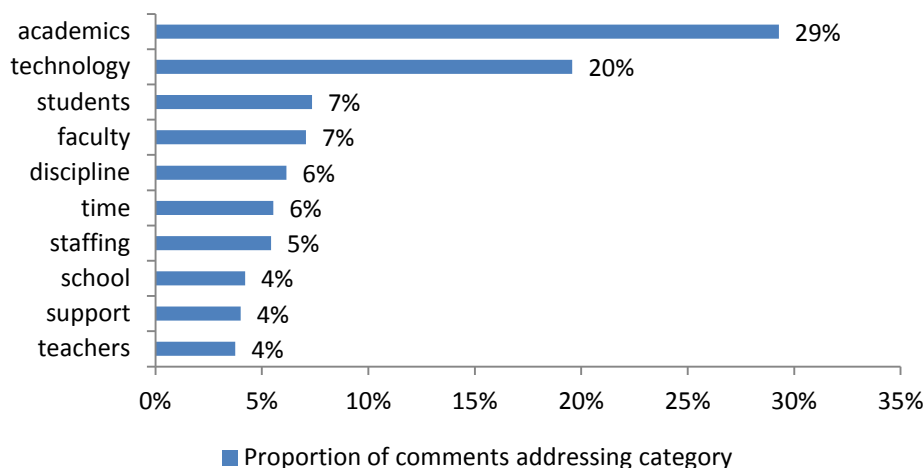


## Open Responses

The results outlined in the previous sections describe the participants' responses that were made by selecting from a set of defined options. This strategy provides a means of collecting a range of perceptions that lead to a ready comparison across school sites and respondent groups. However, the data are limited to the questions and possible responses that were included by the designers of the survey. To provide the participants an opportunity to express other concerns or issues, a question was included to allow listing of up to five topics that they wanted the principal and District administration to consider. The participants were free to list any topic, positive or negative. The following is a high-level summary of the topics identified by each group. Detailed summaries, excluding any of the participants' identifying information, are provided separately to the school principals and District administrators. As revealed in the following summary, while there is some overlap, each of these groups has expressed different sets of concerns.

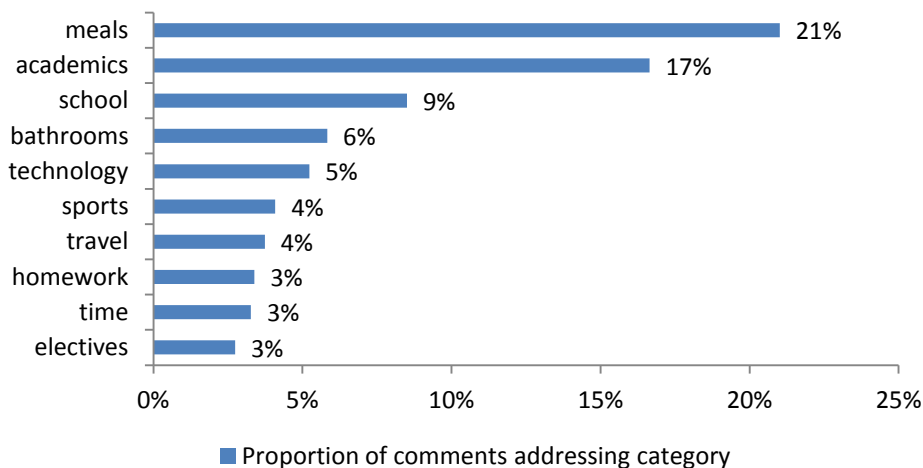
**Figure 10. What's on Teachers' Minds**

A total of 6,773 (69%) teachers provided written responses. Their comments were categorized according to broad themes; the 10 most commonly cited themes are displayed in Figure 10. The broad categories of *academics* and *technology* captured 29% and 20% of the comments, respectively. The *academics* category covered a broad range of issues including student preparation, providing instruction to special populations, and availability and quality of instructional materials. Technology concerns included student access to computers as well as the age and working condition of computers. With regard to comments about students, many teachers mention a need for support with regard to addressing behavioral issues.

Among the student respondents, 85,127 (71%) answered the request for written feedback. The ten most commonly commented categories are displayed in Figure 11. Issues concerning meals and meal times at school were the most commonly discussed topics, addressed by 21% of the respondents. Students raised concerns about the quality and choices of available food, serving sizes (too small), length of the meal period, and student behavior during the meal periods.

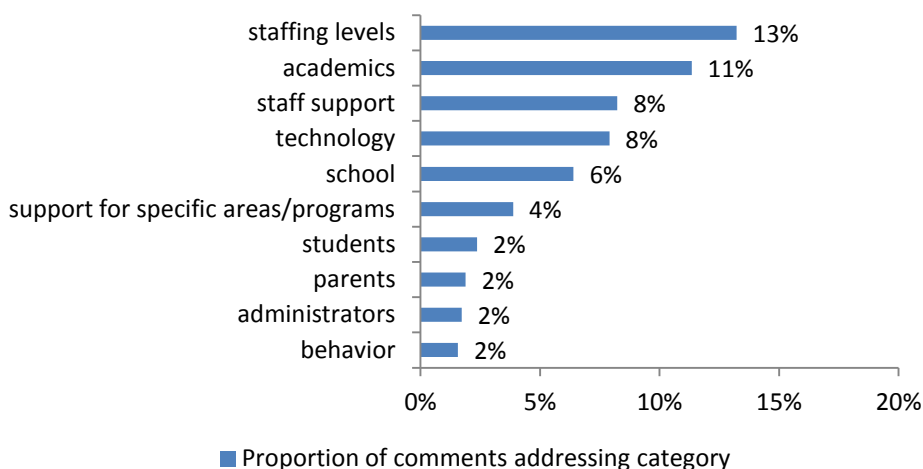
Academics was the second most commonly discussed topic, being addressed by 17% of the respondents. Many comments in this category addressed individuals' concerns about specific classes (e.g., math class is difficult), quality of instructional materials, and preparation for exams. Comments in the school category tended to be generic (e.g., I like school).

Of the non-instructional staff, 1,860 (52%) responded to the written feedback questions. Their responses covered a variety of topics with the ten most common shown in Figure 12. Many of their comments concerned having a sufficient amount of staff to address workloads and operational needs. They indicated that particular programs offered in the school needed additional or dedicated support staff. Many commented on school operations, including hours, safety rules, discipline policy, etc. Staff also commented on the condition of the school facilities and the equipment used for their jobs.

**Figure 12. What's on Non-Instructional Staffs' Minds**

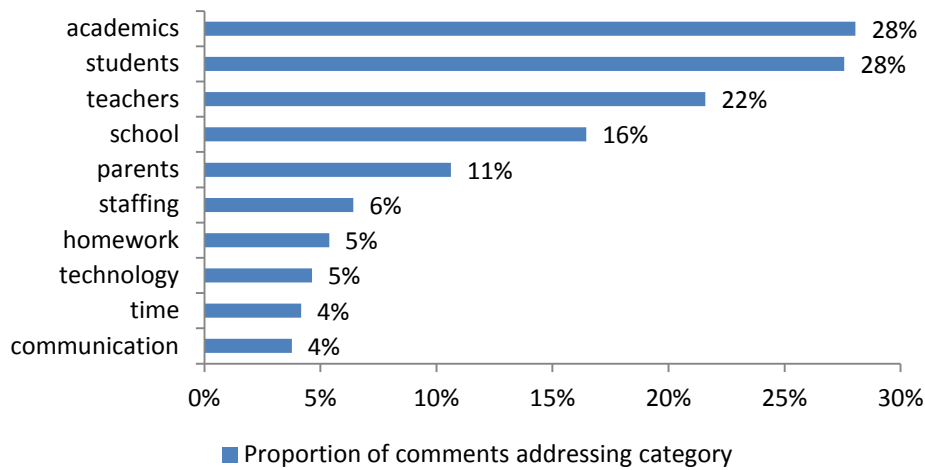


A total of 5,949 (55%) of the responding parents provided written feedback. Many of the comments concerned academics at the schools (28%) such as the quality of instruction, level of academic assistance available at school, and the depth and range of activities available. An



approximately equal proportion of comments concerned the treatment of and opportunities for students. Nearly one-quarter of the comments concerned teachers, either with regard to general teacher quality, teacher’s treatment of students (fair or unfair), and comments about specific individuals. Comments about the school included general statements about the school (this is a good school) and comments on the schools’ rules and operations (e.g., start and end times, need for recess). A number of comments also addressed interactions with non-instructional school staff, amount of homework, quality of technology, and communication with the school.

**Limitations**

The survey offered an opportunity for students, teachers, parents, and non-instructional staff to share their perspectives and provide feedback on school climate. The survey was open to all who wanted to participate. This situation leads to a couple of possibilities that must be considered while reviewing the data. First, participants might not be representative of the overall population served by BCPS—those individuals who completed a survey may have been more motivated or have more extreme views than the population at large. Second, some individuals may have taken advantage of the open access to complete the survey multiple times, thereby allowing their views to be overrepresented. Notwithstanding these limitations, the surveys do provide information that can be used in conjunction with other data sources to build a more complete picture of our schools.

**Next Steps**

This report highlights the responses of students, teachers, parents, and non-instructional staff to the 2013-14 Customer Survey. Tables attached to this report summarized responses to all closed-ended items for students, teachers, parents, and non-instructional staff at the District level and disaggregated by school level. Individual school level reports of the closed-ended responses have been prepared and are available at <http://www.broward.k12.fl.us/sar/>.

School administrators should review the specific data for their schools in conjunction with the summarized data for their school level to identify areas that may need additional attention and investigation. These data may serve as a foundation to enhance communication with staff, parents, and students while addressing school needs. At the District level, the Office of School Performance & Accountability directors may find this information useful as another perspective on the functioning and performance of the schools.
