Any person may present live comments by attending the meeting/workshop at the Kathleen C. Wright Administrative Building, Board room, located at 600 Southeast Third Avenue, Fort Lauderdale, FL 33301. Members of the public may use this helpful guide to register to present in-person comments on an agenda item during the meeting/workshop.

Anonymous comments or comments that do not pertain to the scheduled agenda items will not be accepted. Therefore, each profile must include the person's name, city, and zip code.

Registration In-Person Speakers

CONGRATULATIONS

You have completed the process for registering as a speaker to provide in-person comments on an agenda item during a School Board meeting or workshop.

The Board Chair will recognize your name at the appropriate time during the meeting/workshop. When presenting your in-person comments, speakers are advised to refrain from obscene or vulgar conduct, slanderous remarks, or statements that tend to incite violence or breach the peace. In addition, speakers are to demonstrate proper decorum and model the district's eight character traits: cooperation, responsibility, citizenship, kindness, respect, honesty, self-control, and tolerance. Speakers are reminded to watch the clocks on both sides of the dais as the yellow light will come on to indicate 15 seconds remaining. Use these 15 seconds to wrap up your comments. At 5 secs, after the three minutes expire, the microphone will be reset for the next speaker.
