#### AGE ELIGIBILITY

A student may participate in interscholastic athletics until reaching the age of 19 years and 9 months. Upon reaching that age, the student shall be ineligible for further participation in athletic competition.

#### LIMIT OF ELIGIBILITY

Students are eligible for no more than four consecutive academic years upon entering the ninth grade as defined by the Pupil Progression Plan of the school in which the child is enrolled.

#### **BIRTH CERTIFICATE:**

\*All athletes must have their birth certificate recorded by the athletic director.

\*Authorized agencies are state, county, city bureaus of vital statistics, hospitals, State Department of Washington D.C., Canadian church records or passports.

\*Baptismal certificates are not acceptable except from Canada.

#### INSURANCE FORM:

\*Parents are responsible for carrying accident insurance on their child and sign a notarized form as such. A copy of the policy or card must accompany the insurance form.

\*Twenty-four hour insurance will be accepted EXCEPT for tackle football where special insurance is needed.

#### MEDICAL FORM:

\*Each year athletes must undergo a physical, which clears them for participation in a sport. The parent and the physician must sign this form.

\* Broward County Schools provide a free physical each year at the end of the year for all athletes for fall participation and again in October for winter and spring participation.

# SCHOLASTIC AND RESIDENCY ELIGIBILTY GUIDELINES

#### **ELIGIBILITY**

\*Eligibility is checked in August and not again until the end of December. There is no eligibility status change made at interim or the nine weeks period.

## **SCHOLASTIC**

\*Incoming ninth graders must have been promoted from eighth grade. After the first semester, these freshmen must maintain a cumulative unweighted grade point average of 2.0 to remain eligible.

\*All other students must maintain a cumulative unweighted grade point average of 2.0 in ALL courses taken since entering high school. \* If summer school is available, then it may be calculated in this GPA. Students can make up one half credit to take the place of one half credit failed during the year which will be added to their cumulative GPA.

\* Night school must be completed before the first day of the school year.

#### RESIDENCY

\*Students shall be eligible in the school in which they first enroll each school year, or make themselves a candidate for an athletic team by engaging in practice prior to enrolling in any member school.

\*This rule for athletic eligibility does not supersede the authority of the School

Board to determine where a student attends school.

\*Reassigned students within the same academic year shall not carry eligibility of another Broward County school without a hardship waiver review by the FHSAA and the student's right to due process.

\*If a student's domicile is changed then that is moving residency and the student becomes eligible. If the student without moves his/her parent or other individual with whom the student has lived full continuously for a calendar year, then this will not be considered corresponding change of residency.
