School Hours

Our school day starts at 8:00 a.m. and ends at 2:00 p.m. Please have your children arrive to school prior to 7:55 a.m. This will ensure they are in their seats by 8:00 a.m. and ready to learn. We offer morning care at 6:45 a.m. and we start serving breakfast as early as 7:30 a.m. **<u>Reminder</u>** – Per Fla. Statute Section 1003.31 (2): Please do not drop off students prior to 7:30 a.m., as there is no supervision.

<u>Attendance</u>

Florida Statute 1003.21 states that all children between the ages of 6 to 16 are required to attend school regularly during the entire school year. Statute 1003.24 states that parents are responsible for the school attendance of their children. Parents, if your child is going to be absent, please call the attendance hotline (754) 322-8152 to report the absence. Parents are responsible for their child's regular attendance. To report an absence, visit our website under CONTACT, then select **REPORT AN ABSENCE to submit an electronic form, call** the attendance hotline, or deliver a note to our staff. Our goal is to have ALL students that are able to attend more than 95% of school days. Students that are absent 5% or more days may require parental interventions from school staff. Truancy notifications may lead to more severe penalties. Absences impact the teaching and learning for all students in the classroom. If your child must be absent for an excusable reason, please report the absence within 24 hrs. Our attendance clerk will update all absences that are reported and meet one of the reasons in the attendance policy.

<u>i-Ready</u>

Parents, please make sure your children are completing Reading and Math sessions on i-Ready at home. 45 minutes should be spent weekly on each subject and the goal is to pass at least one lesson in each subject.

IMPORTANT ADDITIONAL INFO:

1. They DO NOT accept medication in the drive-thru! Residents looking to utilize this service must go inside to the pharmacy and drop off to the box located by the pharmacy counter.

2. They DO NOT accept sharps.

3. They DO accept liquid, but it cannot be more than 4 ounces.

If you don't want to go to CVS, our next Drug Enforcement Administration (DEA) Prescription Take Back event will be April 25, 2020, from 10:00 AM - 2:00 PM at Broward Health Coral Springs. The National Prescription Drug Take Back Day aims to provide a safe, convenient, and responsible means of disposing of prescription drugs, while also educating the general public about the potential for abuse of medications.
