^{*}This project is a redevelopment project on a property previously containing a 255 unit mobile home park known as Rancho Margate. The land use of this redevelopment project was approved for a total of 580 units. Phase 2 of this project was recently sold, and a PUD amendment was recently approved, showing phase 1 consisting of 282 garden apartments, and Phase 2 consisting of 160 townhouses.

^{**}The developer provided four different models for the townhouses and is allowing the pre-construction purchasers to choose their model. Three of the models have 3-bedrooms, and one model has 4-bedrooms. The exact bedroom count for Phase 2 will not be known until building permits have been issued for all residential structures.
