FTE Survey Dates 2019-20



Survey 2	
Survey week	October 7 – 11, 2019
Attendance Window	September 26 – October 11, 2019
State Processing	October 14 – November 1, 2019
Date survey closes	December 13, 2019 (Friday)



Survey 3	
Survey week	February 3 – 7, 2020
Attendance Window	January 24 – February 7, 2020
State Processing	February 10 – February 28, 2020
Date survey closes	April 15, 2020 (Wednesday)



Survey 2

10-Day Attendance Window

*Additional days can NOT be added to the survey week
(Survey Week - Monday thru Friday ONLY)*

Schools closed, Wednesday, October 9th

*Six scheduled school days preceding survey week
FTE Attendance Window adjusted to reflect six scheduled days*

Schools closed, Monday, September 30th

- *Survey Week: October 7 – 11, 2019 – **ONLY 4 DAYS***
- *Attendance Window: September 26 – October 11, 2019 – **ONLY 10 DAYS***

FTE ELIGIBILITY

***Must be “in attendance at least one day of survey week or
one of the six scheduled schools days preceding survey week”***

FLDOE FTE General Instructions, Page 9

FTE ATTENDANCE & MEMBERSHIP

- **Membership/Enrollment Requirements**

- ✓ Enrolled at least one day during survey week

- Student who withdraws prior to survey week is NOT reported for FTE

- **Attendance Requirement**

- ✓ Must be present for at least one day during the attendance window

- ✓ **Helpful Hint:**

- DWH run Absences (Minutes and Occurrences/Days) ATTI007

- Notify Administration of students **NOT** meeting the attendance requirement

- ✓ **Reminder Survey 2 is only 10 days for 2019-20**



STUDENT FTE ELIGIBILITY

*Ensuring only those students that meet the FLDOE
FTE Attendance Requirement are REPORTED for FTE funding*

✓ Check Eligibility Status in TERMS

- DWH Student FTE Eligibility Report (SCLI007)
- TERMS A08 Panel is updated based on the attendance records in TERMS

✓ FTE Eligibility OptiSpool Report (ZSDBD098)

- Check OptiSpool **DAILY** during **SURVEY WEEK**
- A program updates the Eligibility Status daily during survey week, and is based on the student's A15 Attendance Panel in TERMS
- Do not update the A08 Panel in TERMS as the program will override based on the attendance records in TERMS
- Once a student meets the attendance requirement, the program will update the FTE Eligibility Status in TERMS

FTE Recalibration



FLDOE combines all FTE for students reported in multiple school districts

Maximum .50 UFTE earned per survey
Maximum 1.0 UFTE for the school year.
(excluding Survey 1 & 4 for DJJ sites)

✓ ***FTE IS SHARED WHEN.....***

- More than one district reports a student for FTE funding
 - Membership and Attendance requirements must be met
- Florida Virtual Schools (FLVS)

Best Practice

- ✓ *Student who enrolls from another school district, contact the prior district to ensure student is actually withdrawn.*



Hourly Equivalent 180-Day School Year

*Districts participating in the Florida Education Finance Program (FEFP)
must operate schools for the hourly equivalent of
180 Instructional Days*

✓ Kindergarten through 3rd Grade (*180 Instructional Days*)

- 720 Instructional hours per year
 - 240 minutes per day
 - 1,200 minutes per week

✓ 4th through 12th Grade (*180 Instructional Days*)

- ✓ 900 Instructional hours per year
 - 300 minutes per day
 - 1,500 minutes per week

Impacts to 180-day School Year

- Early Release Days
- Hurricanes/Natural Disasters



Enrollment & FTE Panels in TERMS

✓ L03 Panel - Enrollment Counts

- Prior Day Enrollment
- Students Active on A03 Panel in TERMS

✓ C13 Panel – FTE Earnings

- Prior Day FTE Earnings (*Up until Date Certain*)
 - Does **NOT** include any reduction for SHARED FTE, FLVS or Null FTE
- Local **TE2028** reflects the C13 Panel in TERMS

✓ Compare the L03 Panel to C13 Panel (TE2028)

- C13 Panel multiplied by 2 (*should be near the equivalent of L03 Panel*)
- Reasons why enrollment is not the equivalent of the C13 Panel
 - Non-ESE VPK, Hospital Homebound Students
 - High School College Dual Enrollment
 - *Awaiting upload from colleges for Non-Embedded Dual Enrollment Courses*
 - Students with incomplete schedules or non-funded courses (999)



TS7006 FTE 1 – Class

***Do NOT PRINT this report – 100's of pages!
SAVE to PDF and review through ADOBE!***

Review every time the TS7006 becomes available in OptiSpool!

✓ **TS7006 generates from the A10 Scheduling Panel in TERMS**

- Student(s) without a schedule on the A10 Panel will NOT appear on this report
- Corresponds with C13 FTE Earning Panel in TERMS
- Confirm student count to your L03 Enrollment Panel in TERMS

✓ **Schools are to confirm each student is generating 0.5000 FTE**

- Reasons why a student is generating less than 0.5000 FTE
 - Total weekly minutes less than minimum requirement for full FTE
 - Student missing courses, or courses reported as non-funded (999)
 - Not a full time student

✓ **Schools are to compare with the BS7006 Report**

- **School of Instruction is different than School of Enrollment**
 - Hospital Homebound, Dual Enrollment (Broward Technical Colleges)
 - Another school has an active student schedule on the A10 Schedule Panel in TERMS
 - If error, contact other school immediately

State FTE Null Reports

✓ FLDOE runs two edit processes: State Processing & Final Close

- Corrections *made by State Processing* will appear on *current* survey's Recalibrated FTE reports
- Corrections *made after State Processing* will appear on *next* survey's Recalibrated FTE reports
- *Null FTE* errors *not corrected by Final Close* will result in *loss of FTE Funding*



Following Reports Must be CORRECTED IMMEDIATELY – Errors not corrected will RESULT IN LOSS OF FTE FUNDING!

- ✓ 70.766 – Student Course Records to be Nulled by Edit
- ✓ 60.984 – Student Course Records Nulled by Edit



HELPFUL REMINDERS

Print the following panels from TERMS on the 1st scheduled school day after Date Certain

- ✓ Print the C13 – FTE Earnings Panel
- ✓ Print the L03 – Enrollment Panels

*Print the following DWH Attendance Reports
Run for the FTE Attendance Window*

- ✓ Average Daily Attendance (ATTI004) (Signed & dated by principal)
- ✓ Attendance Bulletin (ATTI001)
- ✓ Attendance – Minutes or Occurrences/Days (ATTI007)

Run the following OptiSpool Reports once they become available

- ✓ TE2028 FTE-2 School Summary
- ✓ BS7006 FTE-1 by Class
- ✓ TS7006 FTE-1 by Class (*pdf this report – Do Not Print*)
