Requested Action

Approve Capital Fund Amendment #1 changes in revenue and appropriations and a net reduction of \$20,829,192 from the unallocated capital reserve, with an ending SMART Reserve of \$0 and an ending unallocated capital reserve of \$56,700,109.

Impact if the Board Voted Yes or No

If the Board votes "Yes"

From unallocated capital reserves, staff would:

- Fund ADA projects with an expected completion of June 2024.
- Fund SMART program needs projected through July 2024.

If the Board votes "No"

- ADA projects will be underfunded.

ADA Projects

The Facilities staff identified ADA projects totaling \$2,341,731 and recommended completion this school year. Exhibit D, page 37 includes a detailed listing.

Project Closeouts

In this Capital Fund Amendment, SMART project closeouts add \$2,248,230 to the SMART reserve and DEFP project closeouts add \$3,610,489 to the unallocated reserve. Total savings from project closeouts are \$5,858,719. Exhibit F, page 39, and Exhibit G, page 45 include a detailed listing of project closeouts.

• Insurance Recovery

\$4,140,000 was received from insurance for April 2023 flood claims. This is an open claim and additional payments are anticipated.

- Guardrail 3: School Support The ongoing work of the SMART program allows the District to continue to enhance schools for students and staff.

Measurable Outcome(s)/Return on Investment

Funding these requests allows staff to continue with planned ADA projects and the SMART Program.

Financial Impact

This item fully allocates the SMART Reserve and has a net reduction to the unallocated capital reserve of \$20,829,192. The SMART Reserve will be \$0, and the unallocated capital reserve will be \$56,700,109.
