# BLACK HISTORY MONTH

Broward County Public Schools Celebrates Black History Month, an annual celebration of achievements by African Americans and a time for recognizing their central role in U.S. history. The event grew out of “Negro History Week,” the brainchild of noted historian Carter G. Woodson and other prominent African Americans. Since 1976, every U.S. president has officially designated the month of February as Black History Month.
