

- GA can help to develop your idea by facilitating a group brainstorming meeting, conducting a needs assessment and creating a program plan.
- GA can help to identify funding opportunities through the Grant Funding Newsletter, cultivating donors, and providing individual research.
- GA can work with you to ensure a timely submission, seek School Board review and approval of the grant, and provide editing and writing support.
- GA can help set-up the grant account, support the grant agreement review and approval process, provide donor stewardship, and support media outreach efforts.
- GA can help you to manage the award by supporting the reporting process.
- If applicable, GA will liaise with the Accounting & Financial Reporting Department for assistance with the final financial report.

#### Broward Sheriff's Office Awards Grant to Whiddon-Rogers Education Center

Every year, the **Broward Sheriff's Office (BSO)** helps organizations further their mission in the community through the Law Enforcement Trust Fund (LETF). LETF money comes from the seizure and forfeiture of contraband that has been used in the commission of a felony, and state law allows BSO to use those funds for the benefit of the community. BSO has awarded a LETF grant of \$10,000 to Whiddon-Rogers Education Center to support their Criminal Justice Academy that introduces students to various careers in all major areas in the criminal justice system. Through this work, students are provided with information to develop tools necessary to work and become successful in the criminal justice community. # BCPS Awarded Grant for Intensive Afterschool and Weekend Academies



The **Florida Department of Education** has awarded BCPS a grant of **\$4,101,189** to support *Intensive Afterschool and Weekend Academies* district-wide. Funding will support tutoring and enrichment activities to engage students who have been disproportionately impacted by the coronavirus. The program includes face-to-face, whole group, small group, and/or one-on-one targeted instruction to provide immediate corrective feedback to remedy any deficiencies in the areas of literacy, science, and/or mathematics. Instruction is supported by data-driven analysis from recent assessment results to include State end of year exams and District-approved progress monitoring tools. #### Congressional Earmark Grant



The **US Department of Education** through its Congressionally Directed Awards Earmark program has awarded BCPS a grant of **\$500,000** to expand the successful peer mentoring programs, Mentoring Tomorrow's Leaders (MTL) and Latinos in Action (LIA) to additional schools across the district. The MTL program, implemented through the Diversity & School Climate department, is a peer-to-peer mentoring and student leadership program that serves youth who are atrisk for not graduating or are struggling academically. The Bilingual/ESOL department partners with LIA, a national recognized organization, to offer an asset-based approach to bridging the graduation and opportunity gap for Latino students. The goal of both programs is to dimmish the achievement gap for minority students and to build College and Career Readiness skills.





Grief-Sensitive Schools Initiative

#### New York Life Foundation – Grief Sensitive Schools Initiative

Through its Grief Sensitive Schools Initiative, the **New York Life Foundation** has awarded BCPS a **\$165,000** grant to raise awareness about the prevalence of childhood bereavement. The grant provides schools with resources, training, and practical tools to increase knowledge and build the capacity of schools to support grieving students and their families. To participate, each school must have a minimum of five school staff attend a New York Life Grief-Sensitive School session led by New York Life ambassadors. Schools that complete the training are awarded the Grief-Sensitive School designation and are eligible for a \$500 grant to help enhance grief support and resources available in their school community. Thank you, New York Life Foundation, for bringing this important initiative to Broward.



#### **Walmart Community Program Grants**

**Walmart** awards local cash grants ranging from \$250 to \$5,000. Every school within 25 miles from a store or distribution center is eligible to apply. 


#### A Budding Botantist Grant Winner

### **BCPS Grant Writer in Action!**

Name: Luisa Dugas

**Position:** Art Teacher, Croissant Park Elementary

Years of service: 11

How many grants have you been awarded and what is the total dollar amount awarded? I have won four Broward Education Foundation (BEF) Teacher Innovation Grants: Printmaking Magic Exploration, Back to the Past, Funtastic Florida and Clay Creative. Four BEF Disseminator Grants: Printmaking Magic Exploration, ABC-Arts, Books and Creativity, Back to the Past, a study of Ancient Civilizations and Trailblazers: Women who made their Mark in the World. I have also been awarded 12 BEF Adapter grants totaling about \$15,000.

Which grant-supported project is your favorite? My favorite grant-based project that I've implemented has been Printmaking Magic Exploration. With the money for this grant, I bought all the tools, supplies and books needed to teach various printmaking techniques in the art classroom. Printmaking has been a passion of mine since I was in college, and the techniques of printmaking have always amazed me because of the impressive results. Teaching this topic, which I am so passionate about, and seeing the joy it brings to my students when they are successful is extremely rewarding.

What is your process for filling out a grant application? The first thing I do when considering applying for a grant is downloading the questions and importing them into a Word document. I do this, so that I know what I should be focusing on answering, and so that I can work on the grant writing at my leisure and not against the clock. Then I jot down my initial thoughts- what I consider my BIG idea, what are my students' needs as it relates to this big idea and then how I want to implement it. Little by little the project and proposal start to come together. Also, I research resources like books, videos, and people who can help me implement this idea. Lastly, I put together a list of items I might need and research cost in order to create a budget. There's a lot of scratch paper and sketches involved!

**Do you have any grant writing tips?** The best tip I can give to others starting out is: Answer the question completely. Some grant questions have several parts in one question. It is important to address every part or aspect of each question. Another is to keep in mind that when writing grants, the people reading, and judging are not necessarily educators and might not know the jargon. It is important to write in colloquial language and not use abbreviations that people in other businesses may not understand and lastly, express your passion. A reader must feel your joy for writing about this topic so they can connect with you and the needs of you<u>r studen</u>ts!

## Tip for the Day: Tips for Writing a Winning Proposal

<u>Grants</u>, to be successful, should be part of your overall <u>fundraising plan</u>, have a <u>calendar</u>, and a dedicated grant writer, either on staff or <u>contracted</u>. Grants come from a variety of sources such as a <u>foundation</u>, a <u>corporation</u> or a <u>government</u> agency, but most require similar information. There are also at least <u>three different types of proposals</u>, ranging from a letter to a full-blown proposal.

<u>Executive Summary</u> The <u>executive summary</u> comes after your cover letter. It helps the grantor to understand at a glance what you are asking. Aim to be complete but brief. The summary gives a taste of the proposal to come and should entice the reader to keep going.

<u>Need Statement</u> The statement of need is the meat of your <u>grant proposal</u>. You must convince the funder that what you propose to do is essential and that your organization is the right one to do it.

Use your expertise to explain it but make it simple to understand.

<u>Goals and Objectives</u> Your goals and objectives explain what your organization plans to do about the problem. State what you hope to accomplish with the project (goals) and spell out the specific results (objectives) you expect to achieve. Brush up on SMART objectives.

<u>Methods, Strategies or Program Design</u> Walk the grantor through exactly HOW you will achieve the <u>goals and objectives</u> you've set out earlier. Be as detailed as you can with a timeline and specifics about who will do what and when.

<u>Evaluation Section</u> Funders want to know that their dollars had an <u>impact</u>. So, decide now how you will evaluate the <u>outcomes</u> of your project. Include what records you will keep or data you will collect, and how you will use that data.

<u>Project Budget</u> Attach a short budget showing expected expenses and income. The expenses portion should include personnel costs, direct project costs, and administrative or overhead expenses.
