JP Morgan Chase Awards \$100,00 Grant to BCPS





Congratulations to the Career, Technical, Adult & Community Education (CTACE) team for receiving a \$100,000 grant from JP Morgan Chase. This grant, given through the Broward Education Foundation, will support National Academy Foundation (NAF) career-themed academies in BCPS schools. NAF provides a rigorous, industry-validated career-themed curriculum that incorporates current industry standards and practices, while fostering cross-curriculum collaboration. The program expects students to participate in paid work-based learning experiences that transitions a student from career awareness and exploration to career preparedness and success. GA supported CTACE staff through the proposal development process.

American Mathematical Society Grant



BCPS believes every young person regardless of ethnicity, gender or class should have access to high quality math education. Unfortunately, persistent gaps still exist in high need schools. To eliminate this gap, BCPS has targeted several high schools with low math proficiency and introduced the Algebra Project (AP) and its outgrowth the Young People's Project (YPP). Using a near-peer mentoring model, YPP trains high school students as math literacy workers to tutor and mentor younger low-income and students of color from their community to successfully develop math skills. With the support of the American Mathematical Society Epsilon Fund grant of \$9,000, BCPS will bring together high school students for five weeks during the summer of 2019 to train the students to work with their near-peers in improving their math skills and building selfconfidence in their math capabilities. GA staff were happy to work closely with Guy Barmoha, Director-Secondary Learning and staff on the proposal.

The Bosch Community Fund has awarded a grant of \$8,000 to expand participation and support success in VEX robotics competitions for BCPS students by ensuring equitable access to training equipment (fields), experienced coaches, and local competitions. Grant Writer in Action

How many total grants have you written? Over 30

How many grants have you been awarded and what is the total dollar amount awarded? I have been awarded 20 grants totaling about \$20,000.

Where do you find success in locating education grants? The Grant Funding Newsletter for BCPS has always been helpful, since it has a section that lists grants offered according to specific months.

How do you determine if a grant you discover is a grant you should apply for? You must always contact the Grants Department first. They will be able to tell you if anyone else has already applied for that specific grant. This is important, because in some cases, if multiple applications are sent in from more than one person in the District, it makes all applications invalid.

Do you wait for a purpose to seek a grant, or do you find a grant and seek a purpose? In the past, I have written grants in order to purchase science supplies for labs. However, sometimes I've written grants just because I am passionate about the cause. Health and Wellness is an area that I've always been interested in, so I applied for the NFL's Keep Gym and Schools grant, the Let's Move Active Schools Grant and the Action for Healthy Kids grant, because I believe that the key to so many obesity related illnesses lies in PREVENTION rather than CURE!

What preparation is involved in writing a grant application? One of the first things you must do is your research! For example, you must find out how many students at your school are on Free and Reduced Lunch. You must also find out the demographic breakdown of the students who attend your school. Statistics work wonders. A previous member of the Grants Department once told me that "when you write a grant, you must NOT ask for what you WANT; you must ask for what you NEED".

What is your process for filling out a grant application? I read over the entire application first to find out what the requirements are. Then, I contact the Grants Department in order to find out if anyone else in BCPS has already applied for the grant. After that, I collect statistics and begin my rough draft. I also ask for feedback from the members of our Grants Department since they are the professionals and they often come up with angles/approaches that I would not have even thought about. Finally, comes the hard part.... You must wait a few months to hear if you were successful. However, I'll reveal a great secret about the waiting period. If you have a person you can contact who is part of the decision-making process, now is a great time to contact them. For example, I applied for a donation from a hair care company, Monat. Through sitting on the Leadership Team at Student Services, I became aware that our HEART (Homeless Education Department) needed toiletries for high school graduates who are part of HEART and are going off to college. I applied several months ago. Since I had not heard anything, I contacted the Monat company to see if there was any more information needed for my application. A few days later, I received an email that they would be donating 250 Kits (valued at \$7,500) to the Heart Program.

Have you discovered certain tips about grant writing that have proved successful? If it is allowed, I include pictures in my application. If people have a visual, it often helps communicate what is happening at your school.

Are you able to recycle some of the content in your grant applications for other grants? Absolutely! I have always been told to "Work Smarter, not Harder!" When you have already gotten your statistics in alignment, that is half of the battle. It would be silly to redo an entire application without recycling some of the content.

Tip for the Day

Tip for the Day: Grant Writing Glossary

- **501(c)(3)** is the section of the Internal Revenue Code that defines nonprofit, charitable, and tax-exempt organizations. BCPS can partner with The Broward Education Foundation (BEF) since public schools do not have 501(c)(3) status.
- **Absolute Priorities** are activities or conditions that must be met for a grant proposal to be considered.
- Audited Financial Statements are annual financial statements which have been prepared and certified by a Certified Public Accountant.
- Capacity Building Grants help organizations to increase their capacity to achieve their mission. This may include the funding of new staff positions; and the costs of consulting to help the organization learn how to manage their boards, increase their fund-raising capacity and expand services.
- Capital Grants fund building of endowments, building renovations and similar activities, construction or equipment.
- **Concept Paper** is a two- to three-page description of your organization and program. A concept paper often includes a need statement, project narrative, and budget.

• **Corporate Giving Programs** have very specific causes they will fund (the arts, environmental education, youth, health). Some companies have their own charitable giving department, while others have a separate foundation.

- **Direct Costs** are costs allowable by the funding organization, and are directly tied to the operation of the project.
- **Eligibility Criteria** is usually available on a grant funder's website. Before spending a lot of time and effort on a grant proposal, thoroughly read whether your organization or program is eligible for funding.
- Evaluation is how the organization assesses whether their project made a measurable difference.
- **Form 990** is an IRS form that tax-exempt organizations, including public charities and private foundations, are required to file annually for public record of financial information. Public schools are not required to have a Form 990.
- **General Support or Unrestricted Grants** are for general operating costs rather than specific projects.
- **Goals** are expressed as the overall vision of what you want your project to accomplish. Be careful about having too many goals because this could be viewed as either being too ambitious or too unfocused.
- Indirect Costs/Indirect Cost Rate (Sometimes referred to as "overhead" or "Facilities and Administrative Costs) are costs that support the management systems of the organization including public relations, accounting, payroll, marketing, registration and records, and counselor. Grant funders may or may not allow indirect costs.
- **In-Kind Contribution** is a noncash donation to a project.
- Letter of Intent or Letter of Interest (LOI) is a document that provides a brief description of the project or program for which funding is being requested.
- **Matching Funds** are cash or in-kind support contributed by the grantee to carry out a project. Some grant proposals require a match before funding a proposal.
- **Objectives** are what specifically will change, improve, decrease, or increase because of your project activities. Many grant writers use the SMART model: Specific, Measurable, Attainable, Realistic, and Time-Bound.
- Request for Proposals (RFP) or Request for Applications (RFA) is a type of solicitation notice in which a donor announces that grant funding is available and provides specifications required in the grant proposal/application.
- **Restricted Funds** are funds that must be spent for a specific purpose, as determined by the funder.
- Unallowable Costs are costs and categories of costs that cannot directly or indirectly be offset by grant money.
- Unrestricted Funds can be used for any purpose without any requirements or restrictions.
