BCPS Receives Additional Funding from the Cornavirus Aid, Relief, and Economic Security (CARES) Act

The Florida Department of Education (FLDOE) through the Coronavirus Aid, Relief, and Economic Security (CARES) Act -Governor's Emergency Education Relief (GEER) Fund has awarded BCPS \$338,983 to support K-12 Civics Literacy. FLDOE and BCPS are committed to preparing students to become civically engaged and knowledgeable adults who make positive contributions to their communities. Grant funds will be used to provide all District elementary, secondary, and combination schools and centers with K-12 civic literacy materials selected from the new BEST English Language Standards civics book list. GA staff facilitated inter-departmental meetings, developed the narrative and budget, and obtained necessary signatures for required documents to support the proposal. Staff also facilitated the consultation process with non-public and charter schools who were also allocated their own grant funds from FLDOE. Thank you, Dr. Nicole Mancini, Director – Elementary Learning, Guy Barmoha, Director – Secondary Learning and their respective teams for collaborating with GA on the proposal.

An additional \$1,855,825 was granted from the CARES Act through the Elementary and Secondary School Emergency Relief (ESSER) Fund for K-3 reading recovery for high-need students. Grant funds from the K-3 Reading Initiative will be used to support students with gaps in reading foundational skills in 50 elementary schools and four center schools. The K-3 Reading Initiative aims to improve decoding and reading skills in phonemic awareness, spelling, fluency, vocabulary, handwriting, grammar/syntax, and pronunciation using various multi-sensory techniques in both direct instruction and interactive computer software to reinforce skills taught in the classroom. GA staff supported the proposal development process by providing budget review and editing support; facilitated the consultation process with non-public and charter schools; and provided technical assistance in collecting information from schools. Grant Writer in Action

Name: Luciana Gentile

Position: Literacy Coach – Ramblewood Elementary School

Years of service: 16 years

How many grants have you been awarded and what is the total dollar amount awarded? The first grant I applied for was the \$700.00 Target Field Trip grant. With this grant, I was able to take my students to the Museum of Discovery and Science and the IMAX theater. It was an amazing experience. Since then, I have applied and been awarded the Target Field Trip grant two additional times. I also received a \$250 grant from Aldi's to transform the 5th grade classrooms in my school into a Reading Cafe. Another grant I have applied for and been awarded for the last three years, is the Broward Education Foundation Adapter Grant in the amount of \$400.00 each. This grant allows me to adapt the amazing ideas from the Broward Education Foundation's Teacher EXPO to fit my school's population and needs. In addition to that, I also applied for a \$1,000.00 TGIF grant to attend a Reading Recovery Conference in Ohio last year.



Luciana Gentile, Teacher – Ramblewood Elementary School

Which grant-supported project is your favorite? My favorite project was the Colonial Life Project. In this project, students were immersed in American History. The grant allowed me to purchase books and materials for creative activities. This project culminated in students living a day in the life of a colonial times child.

What is your process for filling out a grant application? I try to research the grant before I apply. I read everything on the website and look at examples from prior winners. As for the idea for the grant, I keep a journal of ideas throughout the school year. I start with a standard or a cluster of standards and then think of a creative and engaging way to teach it. I love project-based learning, so I design a plan for students to learn by actively engaging in real-world meaningful projects. Once I have a clear vision of my idea, I think of the materials that would be needed to implement it. I then write up the project explaining it in a way that anyone can easily understand. Often, the committees granting the funds are not comprised entirely of educators, so it's important to be clear in demonstrating the need and explaining how the grant will help meet that need. Ultimately, everyone involved just wants to know how the grant will benefit the students. When I write the narrative for the grant, I don't just explain the academic impact, often I include the social-emotional impact as well.

Do you have any grant writing tips? Yes, it's important to include in the narrative a strong objective and assessment piece. I include a pre- and post-assessment when appropriate. In addition, I embed assessments throughout each part of the granted project. When writing the grant, I include a detailed explanation of the embedded assessments in order to explain how I will analyze the impact of the grant. Assessments can include products, performance tasks, and portfolios. This part is important because it supports the claim for a need and gives evidence of the positive impact of the grant funds.
