## Good News!

### U.S. Department of Education Continues Supporting Recovery Programs at BCPS

In March 2018, BCPS received a **\$1 million** grant from the U.S. Department of Education's Project School Emergency Response to Violence (SERV) to assist schools in dealing with the aftermath of the Marjory Stoneman Douglas High School tragedy. The grant covered hiring additional personnel, summer activities, trauma-focused cognitive behavioral training, postsecondary transition assistance, and health and wellness activities for students and staff. BCPS was recently awarded an additional **\$2,483,273** from SERV to cover personnel costs associated with recovering from the incident and addressing the continued effects of the tragedy. Thank you to staff from Student Support Initiatives and Recovery and the cross functional District and school-based team including: Marjory Stoneman Douglas High School staff, Office of Safety, Security and Emergency Preparedness, School Performance and Accountability, Facilities, Employee Assistance Program, Instructional Staffing, Finance, and Academics to name a few. This was truly a collaborative effort with the GA team to develop and submit the proposal and budget revisions while working closely with the U.S. Department of Education's guidelines to secure this second round of funding. We appreciate their generous support of the District's recovery efforts.

A copy of all grant applications to external agencies must be submitted to the Grants Administration (GA) department as soon as possible to obtain School Board approval. Grant contracts and funds will not be awarded without Board approval. ## Grant Writer in Action

**Teacher:** Tara Dukanauskas - North Andrews Gardens Elementary School

**Position:** Grades K-5 and implemented projects across many grade levels

**Years of service:** 30 plus

**How many grants have you been awarded and what is the total dollar amount awarded?**

I have applied for and been awarded numerous grants over the years --probably over 50 in total. Awarded grants include support from the Broward Education Foundation, and STEM and garden grants from various corporations and agencies. Total awarded is about \$20,000.

**Which grant-supported project is your favorite?**

It is hard to choose a favorite as all the projects tend to be hands on and bring needed materials to the classroom which help the students succeed while enjoying learning. My students have access to a 3D printer, Robots, MakerSpace materials, Kindles, iPads, Merge Cubes, a Garden (in its fifth year) and more because of grant funding. I also really enjoy presenting my grant funded projects to others, especially at BEF's Teacher Expo because other teachers can then share these projects with their students also.

**What is your process for filling out a grant application?**

I start with a project idea in mind and I layout a budget for needed materials. Then I work back from there. The timeline, standards used, lesson activities and evaluation systems all come out of the initial project idea and budget. I also read the rules and, if provided, I look at samples of previous grant winner's work or projects.

**Have you discovered certain tips about grant writing that have proved successful?**

Make sure you are very clear about the project. Describe the who, what, when, where, why and how clearly. Follow the rules outlined in the grant such as number of pages, font size and so forth. I also suggest being creative and thinking outside the box. Have a culminating activity if you can. Involve as many students and teachers as possible. Use volunteers and parental support. Many of my projects include a Family Night component.

**Any other tips?**

Make sure you THANK the people who award you the grants and show them pictures of the project and your students in action to insure future funding. I also have a list of questions I try to make sure I answer in my write up for the grant. Why is this project needed? What materials will you utilize? What is the timeline of events for this project? How will the project be implemented? Who will be involved in the project and who will implement the project? What resources are available to you and what resources will you need? Is this a new project or an extension of an existing project? It is also very important to have a clear way to assess the success of the project. How will you show student learning gains? Another tip I would give is to implement projects which are hands-on and cross-curricular. Be specific about the materials you are asking for and why you are asking for them.

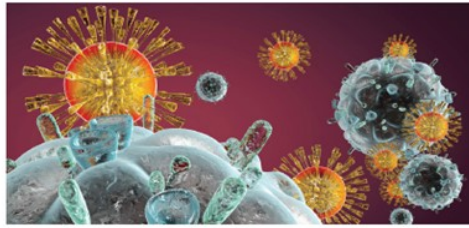
