

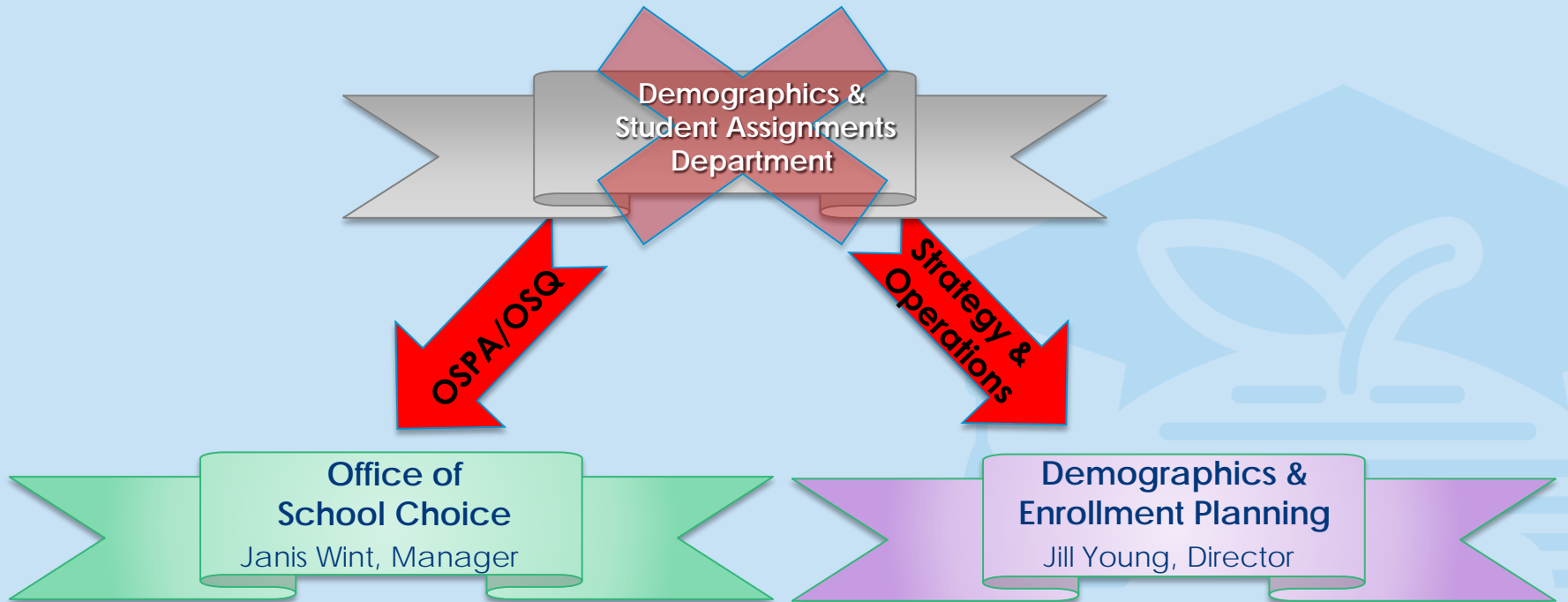

What is School Choice?

- Parents may **request** for their child to attend a school other than the school assigned to their home address
-
- Requests can be for any student within the state of Florida (student must attend school in person)
- Requests are made during a School Choice application window
- When there are more requests than seats available, priorities are honored and then a computerized random selection fills the seats



Can parents apply for the current school year?

- The final 2021/22 School Choice application is August 2 - August 30, 2021.
- Parents will be notified via email weekly on Thursdays.
- All school-aged students, including those who have not been awarded their requested School Choice, must regularly attend school beginning August 18, 2021.
- School Choice is not guaranteed-even if a sibling is already attending the school or the family moves out of the boundary



Can parents apply for the current school year?

- **Before August 30th**, students who do not live within the school boundary may apply for a School Choice to your school
- **After August 30th**, general reassignment, magnet program, and Nova Schools applications are no longer being accepted for the 2021/22 school year. The following are **exceptions**:
 - **Families who move outside of the school's boundary**
 - **Families who have a hardship during the school year**
 - **Broward County Public Schools Employees**
 - **Active-Duty Military families**

School Choice Registration Instructions

- Students who do not live within the school boundary require a District approval in order to attend your school
- **One Choice School View will no longer be used for School Choice approvals for the 2021/22 school year.**
- The school's registration team will receive lists of awarded students.
