The first item of business on the agenda was the approval of minutes for the last meeting held on February 20, 2020. The Chair did not have time to review these minutes prior to the meeting, therefore they will be on the agenda for the next meeting.

The second item of business on the agenda was presented by Mr. Steven Alexander, Investment Advisor with PFM. Mr. Alexander gave a thorough COVID-19 monthly market update and reviewed the quarterly investment report with the Committee. First, he discussed COVID-19, GDP, key economic variables, unemployment rates, consumer spending and income, PMIs, Treasury yield curve, economic outlook, Federal Reserve, CARES Act, Stimulus Plan, corporate spreads, commercial paper, Moody's ratings and the stock market. Then, he reviewed the quarterly market update, asset allocation, long term, 1-3 year self-insurance, 1-5 year self-insurance and GOB Series 2015 Funds.

The next item on the agenda was presented by Ms. Laura Howe, Financial Advisor with PFM. She presented a market update and Certificates of Participation (COPs). First, she discussed

taxable interest rates, tax-exempt interest rates and market dislocation with the Committee. Then, she presented a thorough overview of COPs 2020A. Discussing the negotiated sale with J.P Morgan, district-wide improvements, credit ratings, pricing and aggregate debt service.
