The second item of business on the agenda was presented by Mr. Scott Sweeten, Investment Advisor with PFM. He provided a thorough market update and quarterly investment report reviewing the District's portfolio performance, trade summary, compliance and asset allocation.

Next, she reviewed the District's Debt Management Policy Compliance and Capacity Considerations. Lastly, she reviewed Upcoming Transactions with the Committee: Certificates of Participation (COPs) Series 2022A (Forward Delivery), Certificates of Participation (COPs) 2022B, the Final Tranche of General Obligation Bonds (GOBs) Series 2022 and the Equipment Lease Program.
