The first item of business on the agenda was the approval of minutes from Friday, August 21, 2020. A motion was made to approve, seconded and passed unanimously.

The second item of business on the agenda was presented by Mr. Kyle Jones, Investment Advisor with PFM. Mr. Jones gave a thorough COVID-19 monthly market update. He discussed COVID-19's Impact on the Economy.

The next item on the agenda was presented by Mr. Steven Alexander, Investment Advisor with PFM. Mr. Alexander presented the quarterly investment report with the Committee. He reviewed the quarterly market update, asset allocation, long term operating 1-3 year Fund and long term operating 1-5 year Fund.

The next item on the agenda was presented by Ms. Laura Howe and Mr. David Moore, Financial Advisors with PFM. Ms. Howe presented an economic update and discussed the issuance of the 3rd Tranche - GOB Series 2021, indicating this a great time to borrow while Treasury yields are low.

The last item on the agenda was presented by Ms. Mara Lugo, Financial Advisor with PFM. She presented the Refunding Update of COPs Series 2012A. In March 2020, PFM circulated a RFP on behalf of the District to firms interested in providing forward refunding financing alternatives for the callable portion. By April 2020, the District received (3) three proposals. Based on the results received and discussions with staff, the decision was made to take no action at this time. PFM did provide an updated preliminary analysis and reviewed a summary of those results with the Committee. Interest rates remain near all-time lows with a net present value savings of \$ 6,182,595.00.
