eLearning phase 2

- 75% of our students stayed home
- All assignments stayed on canvas

Spring 2021 Reopening Plan approved December 28th, 2020:

- Executive order
 - Not making academic progress
 - ¼ of the kids are in this category
 - Per State, we strongly encouraged these students to return to school through letters and calls
 - 49% of those students are back in school
- eLearning phase 3
 - Teachers are teaching from classroom assuming everyone is back in schools
 - o 6k polycom cameras for teachers to utilize only with teachers' agreement
 - o Demonstrations utilizing whiteboards

- Those in classrooms will no longer use teams
- Those at home still utilizing teams
- o Canvas is the core for instructional resources
- Last Tuesday we have seen a higher uptick in kids returning to school
- Ensuring supplemental resources, including 3 on demand tutoring to support students
 - $\circ~$ Ask BRIA on student launchpad on Clever and through Canvas
 - Broward County school teachers teaching Broward Kids
 - MECCA Student diversity organization Complete student registration: <u>https://bit.ly/2TYS5FM</u>
 - **SchoolHouse.World** On-demand tutoring from tutors around the world from the folks that built Khan Academy
 - Many campuses have peer-to-peer through Latinos in Action, 5000 Role Models, Young People's Project and similar organizations
- FSA & EOC the state will be requiring all in person testing
- How are you handling staff shortages?
 - Biggest challenge of the pandemic
 - o Contentions and differences are in discussion
 - We have called up full time subs and newly graduated teachers
 - Not seen strong shortage but if you see this please contact your Principal.
- Please clarify your statement of "advocating to the state to suspend accountability of the FSA exam." Does that mean advocating so that it is not a student requirement? Advocating so the FSA scores do not impact the school's grade and/or teacher reviews?
 - Asking for 2 options as we do not see 90% of students in person for May 1st
 - Exams are given but we are not connecting to school grades or teacher appraisals
 - Waive the third grade FSA for promotion and Waive the EOC for HS graduation

Richie Baum – Update

- What are the consequences of not taking EOC which is 30% of grade?
 - If State continues with accountability, student will receive incomplete grade until they take the exam.

- Effective immediately, SAT will no longer give the writing exam or the Subject Exams permanently
- Looking into different scenarios but still waiting on State approval
- Currently all IB, AICE & AP exams are in person.

 - They provide 4 makeup dates
 - All May 14 tests will also be offered May 18 due to EID.

Report on the Missing Children

Enrollment for 2020/21 decreased by 2.6% (6,971 students).

At District schools, enrollment decreased by **8,650** students from 2019/20.

- Increase in habitual truancy (15 or more unexcused absences)
- How many students had not attended since schools reopened = approx. 780
- What was done?
 - Training to staff who take attendance on how to take attendance for virtual learners
 - 5 Memos providing guidance and support to principals
 - New codes for those learning at home
 - Re-engagement strategies will be shared with schools
 - New policy that cameras remain on while you are in class
