## Computer Science



## Current

30,401 students enrolled in CS courses 21,988 elementary 3,290 middle, 5,123 hgh

2,126 AP CSP + CSA exams in 2021 with an overall pass rate of 54.1 %

100% elementary and high and 90% of middle schools with at least 1 CS trained teacher

3 year

60,000 students in CS courses 48,000 elementary, 5,000 middle, 7,000 high

3,000 AP CSP + CSA exams in 2021 with an overall pass rate of 60 %

100% of schools have at least 3 CS trained teachers

5 year

76,000 students in CS courses 60,000 elementary, 8,000 middle, 8,000 high

5,000 AP CSP + CSA exams in 2021 with an overall pass rate of 70 %

100% schools with at least 5 CS trained teachers

In 2012-13, 650 students were enrolled in CS courses and 122 students took the AP CS exam. In 2013, Broward Schools partnered with Code.org to increase access to CS beginning with 2014-15.

The 2020 College Board AP Computer Science Female Diversity Award recognized 10 Broward schools that are closing the gender gap and expanding young women's access to computer science coursework.

2020 AP CS exam participation <u>and</u> passing rate for BCPS female and underrepresented minorities were above both state and national average.
