HUMAN RELATIONS COUNCIL UPDATES

Ms. Russell updated the committee on the feedback from the Human Relations Council conferences that were held on October 27th and November 3rd. The high schools who attended are requesting a follow-up summit to happen in the spring. **Ms. Gordon** shared her thoughts on the summit she attended and provided suggestions. **Ms. Fry** shared that she attended both summits which she felt had two different vibes. She mentioned she informed the Board Members during the Committee Reports of several issues that were brought up at the summits. She also mentioned that she would update the Board members on feedback from the students who attended the summits. **Ms. Fry** stated that she also addressed training teachers around crisis management; and HRC members not attending meetings. **Ms. Washington** thanked all members for their support and feedback. **Ms. Lewis** shared her feedback on the summits she attended. **Ms. Hudge** thanked the committee for their hard work, feedback, and suggestions when it comes to doing what is best for the students. **Dr. Tewari** briefly shared events that happened during the festival of Diwali. **Dr. Tewari** wanted to know if there was a psychiatrist, psychologist, or someone who was an expert in behavior at the summits. Were there any parents involved? Discussion followed

Ms. Gordon wanted to know if more students are appointed to the committee, does that mean it takes more people for a quorum? **Ms. Williams** stated that the Board-appointed membership counts toward quorum. The eight students according to policy 1.51, will have voting rights but not be a part of the quorum. **Ms. Williams** mentioned that the goal is to work on revising policy 1.51 Human Relations Committee. Discussion followed. Policy 1.51 must align with the recommendations on policy 1070.
