

# Beachside Montessori Village General Meeting--SAC Minutes September 27, 2023--Media Center 8:00 am Meeting #1

#### Call to Order

A meeting of the Beachside Montessori Village (BMV) School Advisory Council (SAC) Meeting was held on September 27, 2023, in the BMV Media Center. Mrs. Cidoni called the meeting to order at 8:07 am.

## **Elections for SAC Secretary**

- Election of SAC Secretary—Mrs. Cidoni nominated Stephany Stock and the nomination was opened to the floor to see if anyone else was interested. No one was so a vote was taken and it passed unanimously.
- Approval of SAC By-laws—The SAC By-laws are the rules that govern the SAC. The
  state creates the template, and the school makes necessary adjustments. Mrs. Cidoni
  reviewed the proposed by-laws and asked members to read through them, so the by-laws
  can be approved. As noted in the by-laws, large scale items are voted by roll call.
  Mr. McCaffrey made a motion to approve this year's SAC by-laws, and Mr. Sfera
  seconded the motion. A vote was held, and the motion passed unanimously.

• Introduction of School Improvement Plan (SIP)—Mrs. Cidoni reviewed the goal of the School Improvement Plan and reviewed the school data from last year in order to close-out the 2022-2023 School Improvement Plan.

- New Social Studies Series—Mrs. Cidoni reviewed the rollout of the district's new Social Studies books for both Lower and Upper school grades.

- SOR—Teachers will have access to training, as it becomes available, in the Science of Reading (SOR) to enhance reading instruction.
