



Greetings West Hollywood families,

We are excited to offer the 2021 Summer Experience at West Hollywood Elementary. Below are the three program options available on our campus. Summer Experience days are Mondays, Tuesdays, Wednesdays, and Thursdays from 8:30-12:30 pm.

Summer Learning Opportunity: Scheduled for 85 school locations across Broward County to run for 6 weeks beginning June 21, 2021 and ending July 29, 2021. All students with a disability under the IDEA are eligible to participate in the Summer Learning Opportunity unless the IEP team determines that the student must participate in ESY to receive FAPE. Please note that students attending the Summer Learning Opportunity will be provided with services to access the educational setting (i.e., consultation/collaboration with an ESE teacher, supplemental aids and services, etc.) and will not receive direct ESE services (i.e., specialized instruction, intensive instruction and therapies).

Third Grade Summer Reading Academy: Scheduled for various school locations across Broward County to run for 6 weeks beginning June 21, 2021 and ending July 29, 2021. Students who are invited to attend the Third Grade Summer Reading Academy participated in third grade during the 2020-2021 school year and have not passed any alternative or good cause options.

Extended School Year: Scheduled for 89 school locations across Broward County to run for 6 weeks beginning June 21, 2021 and ending July 29, 2021. Each individual student's IEP team will review data and student progress to determine the need for Extended School Year. Only students whose IEP teams determine that the student requires ESY to receive FAPE are eligible to participate in this summer program. Students who are eligible for ESY will receive the special education and related services determined and documented by the IEP team.
