<p>Violation #51. Plumbing installed; proper backflow devices Prep sink faucet leaking. Repair faucet to stop leaking. Repeated violation.</p> <p>CODE REFERENCE: 64E-11.003(5)(c). Plumbing will be installed and maintained to comply with plumbing requirements, including backflow prevention devices. A mop sink will be provided.</p>
<p>Violation #55. Facilities installed, maintained, &amp; clean Ceiling tiles with water damage and bulging in dry goods storage. Replace ceiling tiles.</p> <p>CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.</p>
