Canned food (baked beans) with dents on hermetic seal, food adulterated. Remove dented can/provide intact canned food without dents on hermetic seal.

CODE REFERENCE: 64E-11.003(1). The food packaging shall not be compromised nor the true appearance, color, or quality of a food be intentionally altered.

Violation #46. Slash resistant/cloth gloves used properly

Extensive ice buildup in ice cream chest-freezer . Repair freezer to stop ice buildup.

CODE REFERENCE: 64E-11.003(2). Slash-resistant and cloth gloves used properly.

Violation #56. Ventilation & lighting

Several light bulbs not working around kitchen. Replace light bulbs.

CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.
