Violation #13. Food in good condition, safe, & unadulterated

Canned (diced tomato) with dents on hermetic seal, food adulterated. Remove dented can/provide intact canned food without dents on hermetic seal.

CODE REFERENCE: 64E-11.003(1). The food packaging shall not be compromised nor the true appearance, color, or quality of a food be intentionally altered.

Violation #21. Hot holding temperatures

Hot TCS food (pizza) tested 124 F, not held at 135F or above. Reheat foods at 165F/Reheat commercial product at 135F or above. Placed to reheat.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.

Violation #56. Ventilation & lighting

Observed lightbulb not working in dry goods storage. Replace light bulbs.

CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.
