 - g. 2021/2022 Proposed Projected Budget: \$9.61 million
 - i. \$3.7 million instructional staff
 - ii. \$1.8 million support staff (for students, for administration)
 - iii. \$4 million categorical (athletics, security, transportation, ESE funding, etc.) iv. \$46,000 special revenue funding

 - i. 106 teachers
 - ii. 4 guidance counselors
 - iii. 1 BRACE advisor
