<p>Violation #21. Hot holding temperatures Hot TCS food (veggie burrito) tested 128 to 130 F, not held at 135F or above. Reheat foods at 165F/Reheat commercial product at 135F or above. Corrected on site, place to reheat.</p> <p>CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.</p>
<p>Violation #36. Thermometers provided & accurate Refrigerator (milk cooler by right side of kitchen) thermometer is not working. Provide proper working thermometer.</p> <p>CODE REFERENCE: 64E-11.003(4). Thermometers must be calibrated to ensure accuracy in accordance with Rule requirements. Food thermometers scaled in Celsius (C) shall be accurate to plus or minus 1°C or in Fahrenheit (F), accurate to plus or minus 2°F. Food thermometers should be accessible for use by employees and have a probe size appropriate to the food item.</p>
<p>Violation #39. No Contamination (preparation, storage, display) Commercially made pre-packed food item (sunflower seed package) held inside salad container in contact with food. Protect food by use of packaging, counter, use of display cases; or other effective means.</p> <p>CODE REFERENCE: 64E-11.003(2). Food shall be protected from sources of contamination and stored in a clean, dry location at least 6 inches above the floor.</p>
