QAC sanitizer concentration level measured 100PPM in manual operation (3 comp. sink). Manufacturer's specification requires concentration of 200-400PPM. Provide sanitizer level according to manufacturer specification. -Tablets were added to solution. New solution tested at 400PPM. Corrected on site.

CODE REFERENCE: 64E-11.003(2). Food shall only contact surfaces that are clean and sanitized.

Violation #47. Food & non-food contact surfaces
Extensive ice buildup in milk chest. Milk chest located by left serving line. Repair milk chest to stop ice buildup.

CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.
