Procedures for Exam Exemption Form

- The link to the Exam Exemption Form will be sent to CANVAS on Thursday, Thursday, May 20th. Teachers should review procedures and Frequently Asked Questions with their students.
- 2. Student and parent signatures (typed) must be completed before the form is submitted.
- Students will complete and submit the Exam Exemption Forms no later than Tuesday, May 25th, 2021, at 7:00PM.

Frequently Asked Questions

- Q: Does a student have to report to school to take an exam?
- A: Only those students that have opted for Face-to-Face Instruction should report to campus during their exam time. All other students will take their exams remotely.
- Q: Does a student that has opted for Face-to-Face Instruction have to report to school during an exempted exam?
- A: No, but there will be a holding area available for all exempted students that are on campus.
- Q: If a student exempts the first, third, fifth, seventh block exam, can the student report directly to the second, fourth, sixth, eighth block exam?
- A: Yes. Students arriving earlier than the exam start time must report to the holding area.
- Q: Can a student that is exempt from the second, fourth, sixth, or eighth block exam leave campus without signing out after their first, third, fifth, or seventh block exam?
- A: Yes.
- Q: Does a student exempting the first and second exams, third and fourth exams, fifth and sixth exams, or seventh and eighth exams need to report to school on the exempted day?
- A: No.
- Q: If a student receives an exam exemption, will the absence count?
- A. No
- Q: How will a student know if his/her grade falls below a B before the exam?
- A: It is the student's responsibility to confirm his/her exemption status before the scheduled exam.
- Q: Can a student with all As and Bs take all of his/her exams?
- A: Yes.
- Q: If a student completes the form to exempt the exam, can the student take the exam anyway?
- A: Yes.
- Q: Can a student exempt the same class for both mid-term and final exams?
- A: Yes, as long as the exam exemption procedures are followed.
- Q: I thought AP finals could not be exempted? What about a PreAP course?
- A: AP midterm exams cannot be exempted, but AP final exams can be exempted. PreAP midterm and finals can be exempted.
- Q: Do End of Course (EOC) classes have final exams?
- A: EOC courses (Algebra 1, Geometry, Biology, U.S. History) DO NOT have final exams.
- Q: Why is there a deadline to turn in the Exam Exemption Form?
- A: Staff needs time to notify teachers of each student that is opting to exempt an exam.
- Q: What if a student improves his/her grade to an A or B after the deadline date to turn in the form?
- A: Student must take the exam.
- Q: Will there be a list of exempted students?
- A: An Excel spreadsheet will be maintained for all exempted exams.
- Q: If bus students have another way home, do they have to wait in the holding area?
- A: No.
- Q: Will lunch be obtainable on exam days?
- A: A "grab and go" lunch will be available each exam day. The regular lunch prices will apply.
