WESTERN HIGH SCHOOL—VEHICLE PARKING CONTRACT

Students: Please read each of the following statements and sign your initials on the line. By initialing on the line beside each statement you recognize that you understand and will obey all parking regulations. Upon receiving my parking permit, I, the undersigned, fully understand that:

- I understand that Western High School and the School Board shall not be responsible for content or damages to automobiles or other vehicles parked or operated on school property. Valuables should not be left in vehicles. **VEHICLES SHOULD BE LOCKED.**
- I understand that I must hold a valid driver’s license and a car that is in safe operating condition as set by the state of Florida that has been registered with the school with a valid parking decal.
- I will always display my parking decal from the **rear-view mirror** while on school property **only on vehicles listed on my application or as authorized by the school.**
- I will not be involved with duplicating parking decals (including my own) or **sharing my decal with another student or car.** I will be subject to school consequences including revocation.
- I am not to go over the speed limit (10mph) or drive in an unsafe or reckless manner on or around school grounds. I will follow all proper road signs for directions in the parking lot.
- I will be parked in the student lot in a legal spot no later than 7:40 AM with the front of the vehicle facing the wheel stop. **NO BACKING IN!!!**
- I will **only park in my assigned decal spot in the Student Lot** (south side of campus).
- If my car is towed for being illegally parked, I will be responsible for the towing charges.
- **I will not visit or allow others to visit or loiter around my car before, after, or during school hours. If I need to go to my car during school hours, I must receive administrative approval.**
- I am not to leave school grounds during school hours without prior administrative approval.
- **I will not transport any unauthorized students off campus, or I will lose my permit permanently.**
- I **MUST** maintain an unweighted GPA of 2.0 or greater and **not have any discipline problems such as Internal or External Suspension from school which may result in driving privileges being suspended or revoked.**
- I will not play music at a volume that may be found disruptive to the environment outside of my vehicle.
- I know that, due to the limited amount of parking available, only one decal per household will be issued.
- **DECAL Replacement will be \$5 cost.**
- I **REALIZE THAT DRIVING TO SCHOOL IS A PRIVILEGE, NOT A RIGHT.** This privilege may be suspended or revoked if the above rules are not obeyed, or if my behavior at school indicates that I am not responsible enough to deserve this privilege. I agree to all terms and conditions outlined in this contract.

PLEASE REFER TO PARKING DISCIPLINARY MATRIX FOR INFRACTIONS AND CONSEQUENCES

WAIVER OF SEARCH

- I am not to bring alcoholic beverages, drugs, or weapons on school grounds in my vehicle.
- I will not possess and/or use any tobacco products in or near my vehicle while on campus.

I understand that in order to maintain a reasonable and safe school environment, Western High School’s Administration reserves the right to search under reasonable grounds and seize any property within the vehicle, which violates state law, school regulations, or may be harmful to any person.
