# **Mission Statement**

Attucks Middle School's mission is to provide a quality, personalized education to all students, in a supportive, innovative and safe environment, while providing unique educational opportunities in the study of communications, broadcasting arts and digital media.

#### Parent and Family Involvement

At monthly SAC meetings, parents will have input on the school's Title 1 assignment (including Professional Development and Parent Engagement assignments). Parents will be encouraged to participate in the development and decision-making process of all school-related Title 1 activities. An annual assessment will be conducted using parent and student surveys. The results will be analyzed to evaluate the effectiveness of the school's Parent Engagement Program. Adjustments will be made according to needs.

In addition to Parent Link's weekly communication, we will develop a monthly newsletter that will be posted on our school's website, as well as a hard copy at the school's reception desk.

Workshops will be held to provide parents with tools and information to provide their students with the necessary support for learning at home.

#### Flexible parent meetings

Attucks Middle School will offer a flexible number of meetings, such as morning or evening meetings, and may provide funding under this plan, transportation, child care, or home visits, as such services relate to parent involvement Section 1116(c)(2)].

Parent conferences are scheduled in the morning two days a week and offer flexibility in time slots. ESE parent meetings are held in the mornings and throughout the day to provide convenient times for parents. The social worker makes home visits where needed,

PTSA and SAC are held and supported on the same meeting night. Other events such as Open House, Fairs (such as Literacy, Science, and STEM) are held in the evenings, so parents have the opportunity to participate in all or selected events. SAC parents have approved this collaboration and consider this to be a "Best Practice" that has increased parent involvement in Title 1 parent and student activities. Food and resources are provided on parents' nights.

Magnet Coordinator offers school tours at convenient times for parents. These occur during the school day and are scheduled in advance to accommodate schedules.
