- IV. Ms. Ramsay: Florida School Recognition Funds (A+ Funds) 5:45 PM
  - a. There was a sub-committee formed during the October meeting from volunteers from SAC and administration to work on options for further discussion for the distribution of the A+ funds. This committee consisted of: Dr. Gutzmore, Ms. Ramsay, Ms. Mainer, Mr. Judd, Mr. Laverde, Ms. Lockhart, Ms. Jackson, Ms. Sexton, Mrs. Devlin and Mrs. Relyea.
  - b. The sub-committee presented the options to the SAC members for feedback and a final decision on creating a ballot for fund distribution. Dr. Gutzmore presented the options to the SAC members on behalf of the sub-committee:

### **Option 1**:

- \$13,871.60 of the funds will go to the school to be used for nonrecurring expenditures for educational equipment and materials and hiring temporary personnel to assist in maintaining and improving student performance.
- \$221,945.60 of the funds will be used for a one-time bonus of \$1,946.89 to instructional staff, school administrators, school counselors, social worker, family therapist, and instructional ESE personnel who worked at least 50% of the 2023-2024 school year.
- \$37,214.80 of the funds will be used for a one-time bonus of \$907.68 to clerical staff, facilities personnel, security staff, BRACE advisor, school psychologist, technical support staff, classroom monitors, and educational support professionals who worked at least 50% of the 2023-2024 school year.
- \$4,400.00 of the funds will be used for a one-time bonus of \$400.00 to full-time cafeteria staff who worked at least 50% of the 2023-2024 school year.
- Any leftover A+ Funds will be used for nonrecurring expenditures for educational equipment and materials.

#### V. Ms. Awafodeju: Principal's Report- 6:13 PM

- a. Facilities:
  - i. Building 5 roof work has started. Unfortunately, the roofers did not seal the roof during demolition and during the last rainstorm water protruded into the classrooms and weight room damaging some tables, light fixtures, and ceilings. The contractors have reviewed the concerns and will be making the needed repairs.
  - ii. The Fire Alarm system is still having concerns with system faults. The project Manager and team are looking into the concerns to determine the corrections needed.
  - iii. Building 13 and FISH 283 and 284 still have not been returned to Nova for use. The Project Manager and contractor are still seeking a solution to the noise level concern coming from the AC ducts.
  - iv. Nova has added some new and colorful picnic tables and umbrellas in our Culinary outdoor area and the Crossroads for students to relax and eat under the shade.
  - v. The Culinary program has a new restaurant seating type of room for students to learn how to serve and for hosting various events.

# VI. Ms. Ramsay: School Improvement Plan - 6:19PM

- a. Attendance Goals for the 2024-2025 school year: Nova High continues to outperform other high schools in the district.
  - i. Excused Absence Rate: The District's goal is to meet or exceed an overall 50% excused absence rate. During the 23-24 school year, 54.92% of

- absences were excused. The high school average was 37.79%. Our goal is to improve our excused absence rate by the end of the 24-25 school year.
- ii. Students with Attendance Above 90%: During the 23-24 school year 47.55% of our students attended more than 90% of school days. The average for high schools was 35.45%. Our goal by the end of the 24-25 school year is to maintain or exceed the high average.
- iii. Total Chronic Absenteeism: Chronic Absenteeism is when a student is absent 10% or more full days in a school year. Through the end of the 23-24 school year, 28.4% of our students were in the chronic absent category, the high school average was 41.84%. Our goal is to decrease overall chronic absenteeism at our school by at least 1% by June 2025.
- iv. Severe Chronic Absenteeism: Severe Chronic Absenteeism identifies students who were absent 20% or more full school days. Our school had 6.23% of students in this category by June 2024. The average for high schools was 12.83%. Our goal is to decrease severe chronic absenteeism with our school community by June 2025.
