Refrigerated equipment (milk cooler) ambient air temperature is 50 F. Ambient air temperature of 41F or less required. Maintain equipment closed when not in use. Equipment was open for lunch prior inspection, milk tested within required temperature.

CODE REFERENCE: 64E-11.003(2). Proper methods shall be used for cooling in accordance with Rule requirements. There should be enough equipment to meet the demand of the food operation.

Violation #55. Facilities installed, maintained, & clean

Ceiling tile with black mold-like substance by employee bathroom area. Replace ceiling tiles.

CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.
