Call to Order:

A meeting of the Everglades Elementary School Advisory Council was held in person in the school's media center on February 7th, 2022. Chair Jessica Schneider called the meeting to order at time 2:39pm. Nizaliz Coley will record minutes for this meeting.

Minutes:

Introduction of Members:

All current members have been introduced.

Review of Previous Meeting (January 2022):

Mr. Buitrago made a motion to accept the notes from the previous meeting. The group unanimously accepted.

A+/Accountability Funds:

Mrs. Schneider clarified our previously discussed motion for the A+ funds (\$10,834.00) as well as the accountability funds (\$9,657.05) which rolled over from the previous year.

The SAC committee previously discussed using the money toward the I-Ready digital toolbox. Unfortunately, we are still waiting for a quote from the vendor for the total cost. We will wait for the quote before officially voting.

Safety and Security:

Mr. Tillinger clarified the SMART bond fund which totals \$36,000, was previously voted on and intended for security; door buzzers and perimeter fence had both been considered. However due to the large cost of the fence, we will continue previous discussions and vote today on using the SMART bond allowance for a digital marquee in front of the school to replace the existing aging marquee.

Mr. Buitrago noted possibly using the money towards the playground or school enrichment programs. Mr. Tillinger shared that due to the age of the school, our playgrounds are scheduled for a district update soon. Mrs. Schneider shared we are currently offering enrichment program with different funds, as this committee traditionally votes to use funds each year for the enrichment tutorials to benefit all students.

Mr. Buitrago then made a motion to change the SMART bond funding from security towards the digital marquee as proposed. Mrs. Soffer second the motion.

The SAC members unanimously voted to transfer the use of funds.

SESIRS:

Mrs. Hines shared we did not receive any new reports since our last meeting.

Mid-Year Reflections:

Mrs. Schneider shared the leadership team has recently reflected on our School Improvement Plan and is happy to report that students are displaying significant growth in the areas of concern. The committee reviewed mid-year reflection from SIP, currently posted in OSPA database.

Updates/Concerns:

Mrs. Hines shared that our PTA is hosting a Fun-Run fundraiser in the upcoming week. The PTA member hub website, Facebook and Instagram page shares instructions for making donations. Mrs. Hines also shared our school offers a direct donation option in our school estore.

Meeting Adjournment:

Motion: Mrs. Schneider motioned to adjourn the SAC meeting at 3:10 pm.
Motion carried unanimously.

Mrs. Schneider shared the next District area Advisory Forum meeting will be later this month. We will review SAF updates at our March meeting.
