CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.

Violation #38. Insects, rodents, & animals not present

Dead insects on glue trap inside laundry room. Remove dead/trapped insects/rodents. Observed facility receives pest control services from Tower Pest Control, last visit on 3/12/25
