Violation #1. Demonstration of Knowledge/Training

Food employee (server) x 2 not aware of foodborne illness symptoms or diseases. Review/provide foodborne illness training.

CODE REFERENCE: 64E-11.003(3). All individuals working in the food establishment have documentation of being trained on Chapter 64E-11, FAC, which relate to their duties and responsibilities.

Violation #45. Single-use/single-service articles: stored & used

Single-service items, meal trays, not properly stored/ protected from contamination in serving area. Store single-use items away from area/sources of contamination. Corrective action taken. Items stored properly by staff.

CODE REFERENCE: 64E-11.003(4). Single-service/Single-use articles must be properly stored and protected to prevent possible contamination. Discard items after use.

Violation #56. Ventilation & lighting

One ceiling light in disrepair, not working in serving area. Provide effect lighting

CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.
