<p>Violation #39. No Contamination (preparation, storage, display) OBSERVED TEA BAGS NOT COVERED IN FOOD STORAGE ROOM. CODE REFERENCE: 64E-11.003(2). Food shall be protected from sources of contamination and stored in a clean, dry location at least 6 inches above the floor.</p>
<p>Violation #49. Non-food contact surfaces clean OBSERVED WALKIN FREEZER FLOOR SOILED. CODE REFERENCE: 64E-11.003(4). Non-food contact surfaces shall be kept clean and free of an accumulation of dust, dirt, food residue, and other debris.</p>
<p>Violation #55. Facilities installed, maintained, & clean OBSERVED MOPSINK CRACKED, WALL AT MOPSINK HAS BROKEN TILES. CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.</p>
