Extensive ice buildup on door seal of walk-in freezer. Repair refrigerator to stop ice buildup.

CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.

Violation #54. Garbage & refuse disposal  
Garbage container/dumpster not kept covered with tight fitted lids/covers/doors. Observed one lid caved in and unable to keep dumpster covered. Keep garbage container/dumpster closed, provide tight fitted lids. (Repeat Violation)

CODE REFERENCE: 64E-11.003(5). Garbage shall be disposed of to prevent vector harborage. Trash cans will be durable, cleanable, leak proof, insect and rodent resistant, and non-absorbent. Outside storage area shall be of a smooth, non-absorbent material and sloped to a drain.
