Food thermometers should be accessible for use by employees and have a probe size appropriate to the food item.</p>
<p>Violation #44. Equipment & linens: stored, dried, & handled Improper storage of clean utensils (scoops), handles facing different directions in storage rack near dry goods storage area.- Corrected on site. CODE REFERENCE: 64E-11.003(4). Utensils and equipment must be cleaned, sanitized and air dried prior to storage. Utensils, equipment, and linens must be properly cleaned and stored.</p>
