#### **New Business:**

**Review SAF Bylaws**- changed ARTICLE IV: Section 3: Term of Office to four years instead of three. Approved.

**Discussed Threat Management**: Mrs. Winder explained the procedure in our school and who is involved. Threat management team and staff are trained on updated procedures and a form of prevention.
